Subsequently, Mr. Brewer, for the said committee on Rules, reported that the bill ought to pass.

There being no objection, the rules were suspended, on motion of Mr. Berry, and the bill was read a second time and was amended, on further motion of Mr. Berry, by substituting a new draft with the same title (Senate, No. 1925).

The bill (Senate, No. 1925) was then ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.
