Monday, February 2, 2004.

Met at one minute past eleven o'clock A.M. (Mr. Rosenberg in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Senator from Hampden and Hampshire, Mr. Knapik, led the Chair (Mr. Rosenberg), members, guests and employees in the recitation of the pledge of allegiance to the flag.

Petitions.

Emergency Preamble Adopted.

An engrossed Bill relative to the Department of Finance in the town of Brookline (see House, No. 4088), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the

Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President and sent to the House for enactment.

There being no objection, the rules were suspended, on motion of Mr. Knapik, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

Order — Amended.

The following House Order (approved by the committees on Rules of the two branches, acting concurrently) was considered forthwith, as follows:

*Ordered,* That the joint committees on Health Care, Insurance, and Ways and Means and the House committee on Medicaid be authorized to sit jointly and report on the initiative petition of Harold Hestnes and others for the passage of a Proposal for an Initiative Amendment to the Constitution relative to the provision of health insurance (House, No. 4444).

Pending the question on adoption of the order, Mr. Knapik offered an amendment striking out the words "the joint committees on Health Care, Insurance, and Ways and Means and the House committee on Medicaid" and inserting in place thereof the following words:— the joint committees on Health Care and Insurance, the House committees on Ways and Means and Medicaid and the Senate committee on Federal Financial Assistance."

The amendment was adopted.

The order, as amended, was then adopted.

Sent to the House for concurrence in the amendment.

Engrossed Bill.

The engrossed Bill further regulating the early retirement of eligible employees of the Nashoba Associated Boards of Health (see Senate, No. 2185) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the Acting President and laid before the Governor for his approbation.

Order Adopted.

On motion of Mr. Knapik,—

Ordered, That when the Senate adjourns today, it adjourn to meet again on Wednesday next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.
