## JOURNAL OF THE SENATE.

Thursday, April 10, 2003.

Met at one minute past eleven o'clock A.M. (Ms. Walsh in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Walsh), members, guests and employees then recited the pledge of allegiance to the flag.

#### Distinguished Guests.

There being no objection, the Chair (Ms. Walsh) introduced, seated in the rear of the Chamber, the Somerville High School Cheerleaders. The cheerleaders recently won the 2003 American Open National Championship Medium Varsity Division Title. They were the guests of Senator Shannon.

## Communications.

A communication was received from the President announcing the following appointments:

The Senator from Hampshire and Franklin, Mr. Rosenberg, to the steering committee established (pursuant to 42 U.S.C. Sec. 15405) relative to the Help America Vote Act;
