Thursday, April 24, 2003.

Met at one minute past eleven o'clock A.M. (Mr. Berry in the Chair).

The Chair (Mr. Berry), members, guests and employees then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Berry) introduced members of Girl Scouts of America Brownie Troops 1103 and 1074 from Everett, Revere and Chelsea. They were accompanied by Mr. Joe Giannino, legislative assistant to Governor Romney, and various troop leaders. The scouts and leaders were the guests of Senators Travaglini and Barrios.

Petitions.

Petitions were presented and referred, as follows:

By Ms. Chandler, a petition (subject to Joint Rule 12) of Harriette L. Chandler, Robert Spellane, John J. Binienda, Richard T. Moore and other members of the General Court for legislation to authorize and direct the reinstatement of Sandra L. Kurtinitis as a member in service of the state employees' retirement system;

Festa for legislation to exempt sales of pilot boats from sales tax requirements. Senate Rule 36 was suspended, on motion of Mr. Tarr, and the report was considered forthwith.
