Monday, May 3, 2004.

Met at one minute past eleven o'clock A.M.

The President, members, guests and employees then recited the pledge of allegiance to the flag.

Report.

A report of the Division of Unemployment Assistance (under the provisions of Section 14F of Chapter 151A of the General Laws, as most recently amended by Section 6 of Chapter 142 of the Acts of 2003) relative to the condition of the Unemployment Insurance Trust Fund for March 2004 (received Tuesday, April 27, 2004),— was placed on file.

Petitions.

Adjournment in Memory former Senator Robert L. Cawley.

Ms. Walsh requested that when the Senate adjourns, it adjourn in memory of former Senator Robert L. Cawley of West Roxbury. Mr. Cawley served in the Massachusetts Senate from 1969 until 1972 and as the Director of Senate Personnel from 1972 until his retirement in September of 2000. Mr. Cawley also served as a member of the House of Representatives from 1963 until 1968. Mr. Cawley, a veteran of the Korean War, was a recipient of the Purple Heart. Mr. Cawley also taught at Newbury Junior College and Quincy College and after his retirement was elected to the Massachusetts State Board of Retirement. He is survived by his wife Patricia, his sons Christopher and Robert, his daughters Suzanne and Laura and seven grandchildren.
