## JOURNAL OF THE SENATE.

Thursday, January 19, 2006.

Met at three minutes past eleven o'clock A.M. (Mr. Hart in the Chair).

The Chair (Mr. Hart), members, guests and employees then recited the pledge of allegiance to the flag.

Report.

A report of the Department of Public Health (under the provisions of Sections 5 and 20 of Chapter 111 of the General Laws) relative to inspection of the Bridgewater Correctional Facilities Complex Kitchen (received Tuesday, January 17, 2006),—was read and sent to the House for its information.
