Monday, January 23, 2006.

Met at three minutes past eleven o'clock A.M. (Mr. Hart in the Chair).

The Chair (Mr. Hart), members, guests and employees then recited the pledge of allegiance to the flag.

Communication.

A communication from the Honorable Robert E. Travaglini, President of the Senate, announcing the appointments of Senators Thomas M. McGee, Brian P. Lees, Stephen M. Brewer, Steven C. Panagiotakos and Robert A. O'Leary to the Special Commission established (pursuant to Section 19 of Chapter 15A of the General Laws and Section 137 of Chapter 33 of the Acts of 2005) to make an investigation and study to review the tuition and fee waiver program for veterans,- was placed on file.

Report.

There being no objection, the rules were suspended, on motion of Mr. Rosenberg, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act designating Taj Mahal as the official blues artist of the Commonwealth."
