# JOURNAL OF THE SENATE.

Thursday, January 26, 2006.

Met according to adjournment, at eleven o'clock A.M. (Mr. Rosenberg in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Senator from Hampden and Hampshire, Mr. Knapik, led the Chair (Mr. Rosenberg), members, guests and employees in the recitation of the pledge of allegiance to the flag.

#### Distinguished Guests.

There being no objection, the Chair (Mr. Rosenberg) introduced, seated in the rear of the Chamber, members of an advanced government class from Cushing Academy in Ashburnham. The students were accompanied by their teacher, Graham Wik, and were guests of Senator Brewer.

## Communication.

A communication from the Executive Office for Administration and Finance (pursuant to Section 3B of Chapter 7 of the General Laws) giving notice of the Secretary's intention to amend the fee for temporary licensure charged by the Board of Real Estate Appraisers (a copy having been forwarded to the committee on State Administration and Regulatory Oversight) (received Tuesday, January 24, 2006),—was placed on file.

Read and, under Senate Rule 26, placed in the Orders of the Day for the next session.
