JOURNAL OF THE SENATE.

Thursday, February 10, 2005.

Met according to adjournment at eleven o'clock A.M. (Mr. Tolman in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Tolman), members, guests and employees then recited the pledge of allegiance to the flag.

Communications.

The following communications were severally placed on file:

Communication from the Administrative Office of the Trial Court submitting a copy of a personnel report required by line item 0330-3200 of the Fiscal Year 2005 budget (received Tuesday, February 1, 2005);

Communication from the Division of Insurance submitting a copy of its Annual Report on the Availability of Response Action Contractor Liability Insurance (received Wednesday, February 2, 2005);

Communication from the Massachusetts Highway Department (pursuant to line item 6010-0001 of the General Appropriation Act of 2005) relative to second quarter reports required by line item 6010-0001 of the FY'05 budget (received Thursday, February 3, 2005); and

Petition.

On motion of Mr. Tisei, Senate Rule 20 and Joint Rule 12 were suspended on the petition, presented by Mr. Travaglini (accompanied by bill) of Robert E. Travaglini, Cynthia Stone Creem, Harriette L. Chandler and other members of the General Court for legislation to promote stem cell research,— **and the same was referred to the committee on Economic Development and Emerging Technologies.**
Sent to the House for concurrence.

PAPER FROM THE HOUSE.

A Bill authorizing the city of Brockton to install, finance and operate solar energy facilities (House, No. 2007,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Ms. Walsh, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.
