Met at twenty-four minutes past one o'clock P.M.

The President, members, guests and employees then recited the pledge of allegiance to the flag.

Distinguished Guest.

The President handed the gavel to Ms. Wilkerson for the purpose of introducing one of the top vocal groups of the 1950s, Herb Reed and The Platters. Herb Reed briefly addressed the Chamber and then led the Platters in performing their hit single "Only You".
