Thursday, May 5, 2005.

Met at three minutes past eleven o'clock A.M. (Mr. Havern in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Havern), members, guests and employees then recited the pledge of allegiance to the flag.

#### Distinguished Guests.

The Chair (Mr. Havern) introduced, seated in the rear of the Chamber, Miss Laurel E. Labdon. Laurel is Miss Wheelchair Massachusetts and she will be competing in the National Wheelchair pageant this summer in Albany, NY. Laurel is from Cape Cod and was the guest of Senator O'Leary.

The Chair (Mr. Havern) handed the gavel to Mr. Augustus for the purpose introducing Timothy Murray, Mayor of the city of Worcester.

The Chair (Mr. Havern) handed the gavel to Mr. Brown for the purpose of introducing, seated in the rear of the Chamber, Joseph Graham of Brockton. Mr. Graham made the winning bid at the "New Hope Gala" to be Senator for the day.

#### Report.

- House bill 1726 authorizing the town of Westport to convey certain conservation land to the board of selectmen for the purpose of constructing a public safety complex.

On the question of passing to be engrossed:

• Senate bill 2040 requiring special state police officers to collect certain data.

#### PAPER FROM THE HOUSE.

Emergency Preamble Adopted.

An engrossed Bill enhancing regenerative medicine in the commonwealth (see Senate, No. 2039), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President and sent to the House for enactment.

Report of a Committee.

Ms. Menard, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill validating the actions taken at an annual town meeting and special town meeting of the town of Rockland (printed in House, No. 999).

There being no objection, the rules were suspended, on motion of Mr. Brown, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

### Reports of Committees.

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Therese Murray for legislation to authorize the Department of Highways to acquire and transfer certain parcels of land in the town of Bourne.

Senate Rule 36 was suspended, on motion of Mr. Augustus, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Bonding, Capital Expenditures and State Assets.

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Edward M. Augustus, Jr. and Andrea F. Nuciforo, Jr. for legislation relative to the payment of referral fees to unlicensed employees of insurance producers.

Senate Rule 36 was suspended, on motion of Mr. Augustus, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Financial Services.

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Joan M. Menard for legislation relative to creditable service of certain Massachusetts Community College Council employees.

Senate Rule 36 was suspended, on motion of Mr. Augustus, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service.

Severally sent to the House for concurrence.

Report of a Committee.

Ms. Murray, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Carol G. Davis, an employee of the George Fingold Library (Senate, No. 2029),—ought to pass, with an amendment in section 1, by adding the following sentence:—"Whenever Carol G. Davis terminates employment with the library or requests to dissolve the sick leave bank, the balance of sick leave shall be transferred to the extended illness leave bank.".

There being no objection, the rules were suspended, on motion of Mr. Brown, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2029, amended) was ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

PAPER FROM THE HOUSE.

Engrossed Bill.

An engrossed Bill enhancing regenerative medicine in the Commonwealth (see Senate, No. 2039) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the Acting President and laid before the Governor for his approbation.

Recess.

There being no objection, at thirteen minutes past eleven o'clock A.M., the Chair (Mr. Havern) declared a recess subject to the call of the Chair; and, at four minutes past twelve o'clock noon, the Senate reassembled, Mr. Havern in the Chair.

Report of a Committee.

By Mr. Montigny, for the committee on Bonding, Capital Expenditures and State Assets, on petition, a Bill providing for a partial release of certain land in the town of Granby from the operation of a non-development covenant (Senate, No. 2038).

The bill was read. There being no objection, the rules were suspended, on motion of Mr. Brown, and the bill was read a second time.

Pending the question on ordering the bill to a third reading, Mr. Tolman moved that the bill be amended by adding the following 2 sections:—

"SECTION 4. The last sentence of the first paragraph of subsection (a) of section 279 of chapter 149 of the acts of 2004 is hereby amended by striking out the words 'and Veterans Memorial Rink, Waltham' and inserting in place thereof the following words:— Veterans Memorial Rink, Waltham; and Daly Memorial Rink, Brighton district of the city of Boston.

SECTION 5. Section 121 of chapter 352 of the acts of 2004 is hereby repealed.";

By inserting before the enacting clause the following emergency preamble:—

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to partially release a nondevelopment covenant restriction on certain land in the town of Granby and to authorize certain agreements for the Daly Memorial Rink, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."; and

By striking out the title and inserting in place thereof the following title: "An Act partially releasing a non-development covenant restriction on certain land in the town of Granby and authorizing certain agreements for the Daly Memorial Rink in Brighton.".

The amendment was adopted.

The bill (Senate, No. 2038, amended) was then ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

Order Adopted.

On motion of Mr. Brown,—

Ordered, That when the Senate adjourns today, it adjourn to meet again on Monday next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.
