As a result, I missed the following votes: engrossment of "An Act Relative to the Retirement Allowance for Certain Teachers" (S. 2302); engrossment of "An Act Relative to Early Education and Care" (H. 4755); the override on "An Act Promoting Access to Health Care" (H. 4479); acceptance of the conference report on "An Act Making Appropriations for the Fiscal Year 2006 to Provide for Supplementing Certain Existing Appropriations and for Certain Other Activities and Projects" (H. 5056); and enactment of "An Act Relative to Economic Investments to Promote Job Creation, Economic Stability, and Competitiveness in the Massachusetts Economy" (H. 5057). Had I been present for these votes, I would have voted in the affirmative.

Reports of Committees.

Mr. Buoniconti for the committee on Ethics and Rules, reported that the following matters be placed in the Orders of the Day for the next session:

The Senate Bill relative to oceans (Senate, No. 2308) (the committee on Ways and Means having recommended that the bill be amended by substituting a new draft with the same title (Senate, No. 2575).

Ms. Murray moved to suspend the rules so that the matter could be considered forthwith; but objection was made thereto by Mr. Tarr.

Under the rules, placed in the Orders of the Day for the next session.

The House Bill to provide licensing for genetic counselors (House, No. 4326).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

By Ms. Murray, for the committee on Ways and Means, that the Senate Bill providing capital facility repairs, grants, and improvements for the Commonwealth (Senate, No. 2385),— ought to pass, with an amendment in section 2, in item 1790-2015, by striking out the words "inspector general for review and approval. The inspector general" and inserting in place thereof the following words:— "auditor for review and approval. The auditor".

There being no objection, the rules were suspended, on motion of Ms. Murray, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2385, amended) was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act providing capital facility repairs, grants, and improvements."

By Ms. Murray, for the committee on Ways and Means, that the House Bill establishing a sick leave bank for Michael McLaughlin, an employee of the Trial Court of the Commonwealth (House, No. 4578),—ought to pass.

There being no objection, the rules were suspended, on motion of Ms. Murray, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act establishing a sick leave bank for Michael McLaughlin, an employee of the Trial Court."

By Mr. Buoniconti, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Robert A. Antonioni, Stephen M. Brewer, Harriette L. Chandler and Lewis G. Evangelidis for legislation relative to the retirement of Harold Lane.
