# JOURNAL OF THE SENATE.

Tuesday, July 5, 2005.

Met at four minutes past eleven o'clock A.M. (Mr. Havern in the Chair).

The Chair (Mr. Havern), members, guests and employees then recited the pledge of allegiance to the flag.

#### Petitions.

Mr. Nuciforo presented a petition (accompanied by bill, Senate, No. 2149) of Andrea F.
