### JOURNAL OF THE SENATE.

*Wednesday, April 2, 2008.*

Met at one minute past eleven o'clock A.M. (Mr. Rosenberg in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Senator from Norfolk, Bristol and Middlesex, Mr. Brown led the Chair (Mr. Rosenberg), members, guests and employees in the recitation of the pledge of allegiance to the flag.

#### *Communication.*

A communication from the Department of Public Health relative to a plan of correction submitted pursuant to inspection of the Western Massachusetts Regional Women's Correctional Center (received Monday, March 31, 2008),— **was placed on file.**

#### *Report.*

A report of the Massachusetts State Lottery Commission (under the provisions of Section 38 of Chapter 10 of the General Laws) submitting its 2007 Charitable Gaming Division Annual Report (received Monday, March 31, 2008),— **was placed on file.**

#### *Petitions.*

Mr. Tisei presented a petition (accompanied by bill, Senate, No. 2602) of Richard R. Tisei, Thomas M. McGee and Katherine M. Clark (with the approval of the mayor and city council) for legislation to authorize the city of Melrose to issue pension funding bonds or notes,— **and the same was referred, under Senate Rule 20, to the committee on Municipalities and Regional Government.**

**Sent to the House for concurrence.**

Mr. Knapik presented a petition (subject to Joint Rule 12) of Michael R. Knapik, Peter V. Kocot and Donald P. Humason, Jr. for legislation to authorize the Department of Fish and Game to acquire a conservation restriction on lands of the city of Westfield,— **and the same was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.**

#### *Reports of Committees.*

Mr. Moore, for the committee on Health Care Financing, that the Senate Bill relative to dementia special care units in long-term care facilities (Senate, No. 425),— **ought to pass (Estimated cost — less than \$100,000);**

By Mr. Morrissey, for the committee on Consumer Protection and Professional Licensure, on petition (accompanied by bill, Senate, No. 2237), a Bill relative to authorizing the city of Northampton to convert five currently issued seasonal all alcohol licenses to annual all alcohol licenses (Senate, No. 2594) [Local approval received on Senate, No. 2237];  
**Read and, under Senate Rule 26, placed in the Orders of the Day for the next session.**

Dear Mr. Clerk:

On Thursday March 20, 2008, I was absent from the Senate floor due to a very important matter in my district. I missed two roll calls. The first roll call was an amendment to H4595 RESOLUTIONS PROVIDING FOR A DECLARATION OF THE INTENT OF THE HOUSE OF REPRESENTATIVES AND THE SENATE RELATIVE TO THE AMOUNT AND DISTRIBUTION OF LOCAL AID TO THE COMMONWEALTH'S CITIES, TOWNS AND REGIONAL SCHOOL DISTRICTS FOR FISCAL YEAR 2009. After debate, the question on adoption of the amendment was determined by a call of the yeas and the nays at one minute before seven o' clock P.M. Had I been present, I would have voted no on this amendment.

The question on adoption of the resolutions (H 4595) was determined by a call of the yeas and nays at five minutes past seven o' clock P.M. Had I been present, I would have voted yes on the resolutions.

I would respectfully request that this letter be published in the Senate Journal as part of the official record. Thank you in advance for your assistance in this matter.

*Engrossed Resolve.*

An engrossed Resolve providing for an investigation and study by a special commission relative to the establishment of a cranberry heritage area (see Senate, No. 2496) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the Acting President (Mr. Rosenberg) and laid before the Governor for his approbation.

Petitions were referred, in concurrence, as follows:

Petition (accompanied by bill, House, No. 4643) of Stephen L. DiNatale relative to the penalties for the use or manufacture of hidden compartments for the purpose of transporting or distributing controlled substances;

**Under suspension of Joint Rule 12, to the committee on Judiciary.**

Petition (accompanied by bill, House, No. 4644) of Cleon H. Turner for legislation to regulate the number of sales tax holidays, so-called, in the Commonwealth.

**Under suspension of Joint Rule 12, to the committee on Revenue.**
