PAPERS FROM THE HOUSE.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Deborah A. Jones, an employee of the Department of Mental Retardation (see House, No. 4928), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 4 to 0.

The bill was signed by the Acting President (Mr. Petruccelli) and sent to the House for enactment.

Engrossed Bill.

An engrossed Bill authorizing the town of Milton to borrow money to fund certain payments (see Senate, No. 2487) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, — was passed to be enacted and was signed by the Acting President (Mr. Petruccelli) and laid before the Governor for his approbation.

Report of a Committee.

By Mr. Panagiotakos, for the committee on Ways and Means, that the House Bill improving tax fairness and business competitiveness (House, No. 4672),— ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2675.

Recess.

There being no objection, at nine minutes past eleven o'clock A.M, the Chair (Mr. Petruccelli) declared a recess subject to the call of the Chair; and, at twenty-six minutes before one o'clock P.M. the Senate reassembled, Mr. Petruccelli in the Chair.

Order Adopted.

Mr. Panagiotakos offered the following order, to wit:

Ordered, That notwithstanding Senate Rule 7, or any other rule to the contrary, the House Bill improving tax fairness and business competitiveness (House, No. 4672), with the new text proposed by the committee on Ways and Means (Senate, No. 2675), shall be placed in the Orders of the Day for consideration of its second reading on Tuesday, May 6, 2008.

All amendments to the bill shall be filed electronically in the office of the Clerk of the Senate by 5:00 P.M. on Monday, May 5, 2008. All such amendments shall be second-reading amendments, but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

Under the rules, referred to the committee on Ethics and Rules.

Subsequently, Mr. Downing for the said committee, reported, recommending that the order ought to be adopted. The rules were suspended, on motion of Ms. Spilka, and the order was considered forthwith and adopted. Subsequently, Senate, No. 2675 was placed in the Orders of the Day for the next session.

Reports of Committees.

By Mr. Downing, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Anthony W. Petruccelli for legislation to establish a sick leave bank for David S. Vitale, an employee of the Administrative Office of the Trial Court.

Senate Rule 36 was suspended, on motion of Ms. Spilka, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on the Judiciary. Sent to the House for concurrence.

Order Adopted.
