JOURNAL OF THE SENATE.

Monday, June 4, 2007.

Met at one minute past eleven o'clock A.M. (Mr. McGee in the Chair).

The Chair (Mr. McGee), members, guests and employees then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. McGee) introduced, seated in the Senate Gallery, students from the Sacred Heart School in Lynn. The students included Mr. McGee's son Thomas and his daughter Katherine.

There being no objection, the Chair (Mr. McGee) handed the gavel to Mr. Hedlund for the purpose of an introduction. Mr. Hedlund then introduced the 2nd grade class from the Foster School in Hingham.

Communication.

A communication from the Honorable Therese Murray, President of the Senate announcing the appointment (pursuant to Section 29A of Chapter 23G of the General Laws) of Vivian Li to the Brownfields Advisory Group for a term to expire on March 20, 2009,— **was placed on file.**

Petitions.

Petitions were presented and referred, as follows:

By Mr. Havern, a petition (subject to Joint Rule 12) of Robert A. Havern for legislation to provide coverage for hearing aids for children;

Report of a Committee.

By Ms. Jehlen, for the committee on, Elder Affairs, on petition, a Bill requiring adequate discharge planning for nursing home residents (Senate, No. 410);

Referred under Joint Rule 1E, to the committee on Health Care Financing.

Callahan and other members of the General Court for legislation to establish collaborative drug therapy management,— **and recommending that the same be referred to the committee on Health Care Financing.**

Under Senate Rule 36, the report was considered forthwith and accepted.

There being no objection, four minutes past eleven o'clock A.M., the Chair (Mr. McGee) declared a recess subject to the call of the Chair; and, at twenty-two minutes before twelve o'clock noon, the Senate reassembled, Mr. McGee in the Chair (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

PAPERS FROM THE HOUSE.

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill establishing a sick leave bank for Yaniris Cabrera, an employee of the Trial Court (see Senate, No. 2181, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency pre-amble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment.

Subsequently, the bill, which originated in the Senate, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Mr. McGee) and laid before the Governor for his approbation.

Recess.

There being no objection, at ten minutes before twelve o'clock noon, the Chair (Mr. McGee) declared a recess subject to the call of the Chair; and, at twenty-two minutes before five o'clock P.M., the Senate reassembled, the President in the Chair.

PAPER FROM THE HOUSE.

A Bill relative to certain real property in the city of Northampton (House, No. 3975,— on petition),— **was read.**

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

Reports of a Committee.

By Mr. Panagiotakos, for the committee on Ways and Means, that the House Bill authorizing the transfer of certain land to the city of Boston (House, No. 53),— **ought to pass.**

There being no objection, the rules were suspended, on motion of Mr. Rosenberg, and the bill was read a second time and ordered to a third reading.

By Mr. Panagiotakos, for the committee on Ways and Means, that the Senate Bill relative to pension divestment (Senate, No. 2217),— **ought to pass, with an amendment substituting a new draft with same title (Senate, No. 2255) (Senator Chandler dissenting).**

There being no objection, the rules were suspended, on motion of Mr. Rosenberg, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2255) was then ordered to a third reading.

Ordered, That when the Senate adjourns today, it adjourn to meet again tomorrow at one o'clock P.M., in a full formal session.
