Order Adopted.

Mr. Tarr presented the following order, to wit:—

Ordered, That by the authority of article IV of section II of chapter 1 of the Constitution, the Senate declares that, by reason of the resignation of Jarrett T. Barrios as Senator from the Middlesex, Suffolk and Essex district, the office of Senator from the Middlesex, Suffolk and Essex district is vacant as of July 5, 2007. By the authority of article XXIV of the Amendments to the Constitution, the Senate directs the president of the Senate to issue a precept setting forth October 9, 2007, as the day for holding an election to fill the vacancy in the Middlesex, Suffolk and Essex district, comprising of ward 3, precinct 2, ward 6, all precincts, ward 7, all precincts, ward 8, precincts 1 and 2, ward 9, precinct 1, ward 10, precinct 2 in the city of Cambridge; the city of Everett; ward 1, precinct 1, ward 2, precincts 1 in the city of Somerville, in the county of Middlesex; ward 2, all precincts, ward 21, precincts 4, 6 and 7, ward 22, pre-cincts 1, 2 and 5 in the city of Boston; the city of Chelsea; ward 6, all precincts, in the city of Revere, in the county of Suffolk; pre-cincts 2, 6 and 10 in the town of Saugus, in the county of Essex.

Under the rules, referred to the committee on Ethics and Rules.

Subsequently, Ms. Menard, for the said committee on Ethics and Rules, reported, recommending that the order ought to be adopted.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the order was considered forthwith; and it was adopted.
