## Engrossed Bill — Laid Before the Governor.

The engrossed Bill making appropriations for the fiscal year 2008 for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (see House, No. 4141) (which originated in the House), having been passed to be enacted and signed by the President on Monday, July 2, 2007,— was laid before the Governor for his approbation on Tuesday, July 3, 2007.

## PAPER FROM THE HOUSE.

Engrossed Bill Returned with Recommendation of Amendment.

A message from His Excellency the Governor, returning with recommendation of amendment the engrossed Bill designating a bridge in the city of Methuen as the Corporal David M. Vincente Bridge (House, No. 3446) [for message, see House, No.

4068],— came from the House with endorsement that the House adopted the amendment as approved by the committee on Bills in the Third Reading, as follows:—

In the TITLE, by striking out the word "Vincente" and inserting in place thereof the following word:—Vicente; and

By striking out the first sentence and inserting in place thereof the following sentence:

The bridge #M-17-010 on Lowell street, Route 113, spanning Bartlett brook in the city of Methuen shall be designated and known as the Corporal David M. Vicente Bridge, in honor of United States Marine Corporal David M. Vicente, who was killed in action in Iraq on March 19, 2004.

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was before the Senate subject to amendment and re-enactment.

The rules were suspended, on motion of Mr. Moore, and the Governor's amendment was considered forthwith and adopted, in concurrence.

Sent to the House for re-enactment.
