JOURNAL OF THE SENATE.

Thursday, October 2, 2008.

Met at six minutes past eleven o'clock A.M. (Mr. McGee in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. McGee), members, guests and employees then recited the pledge of allegiance to the flag.

Communications.

The following communications were severally received and placed on file:

A communication from the Honorable Therese Murray, President of the Senate, announcing the appointment of Mr. John Pourbaix, Executive Director, Construction Industries of Massachusetts, and Mr. Francis X. Callahan, Jr., President, Massachusetts Building Trades Council to serve as her designees on the Special Commission established (pursuant to Section 19 of Chapter 86 of the Acts of 2008) to make an investigation and study of the feasibility of establishing a uniform contractor prequalification process;

By Mr. Downing, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 7B be suspended on the Senate petition of Marc R. Pacheco and Susan W. Gifford for legislation to amend the North Carver water district [Local approval received].

Senate Rule 36 was suspended, on motion of Mr. Tisei, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Municipalities and Regional Government.

Sent to the House for concurrence.

Motion to Take Out of the Orders of the Day — Objections.

Engrossed Bills.

The following engrossed bills (the first three of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr.

Authorizing a certain transfer of funds in the town of Kingston (see Senate, No. 2690);
Authorizing the town of Kingston to install, finance and operate wind energy facilities (see Senate, No. 2691);
Establishing a sick leave bank for Gloria Phillips, an employee of the Department of Public Health (see Senate, No. 2787, changed);
Providing access to information for parents of a child with special education needs (see House, No. 391, amended);
Authorizing the city of Lynn to grant a license for the sale of wines and malt beverages not to be drunk on the premises to Salvv the Florist (see House, No. 4378); and
Authorizing the town of Bridgewater to establish a revolving fund for library purposes (see House, No. 4531).

Emergency Preamble Adopted.

An engrossed Bill providing the terms of certain bonds and notes to be issued by the Commonwealth to finance broadband access, bridge repairs, higher education, transportation, energy and environmental needs and certain, other general governmental needs of the Commonwealth (see printed in House, No. 5095, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.**

The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Gary Tuck, an employee of the Department of Revenue (see House, No. 4754, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.**
The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment.

Adjournment in Memory of Daniel Joseph McCarthy.

The Senator from Worcester, Hampden, Hampshire and Franklin, Mr. Brewer, requested that when the Senate adjourns today, it adjourn in memory of Daniel Joseph McCarthy.

Daniel Joseph McCarthy, died in an automobile accident on Friday, September 26th at the age of 36. Dan was born and raised in Worcester until moving to Palmer in 1996. An avid sports fan, he cheered loudly for all Patriots and Red Sox games, but his special dedication was as a Palmer Youth Baseball coach, and as the most energetic fan at all sporting events played by his son and nephews.

Dan's "larger than life" presence and pure heart will be deeply missed by his wife Jennifer (Noonan) McCarthy, sister of Kara

Noonan Pear, former Chief of Staff to Senator Brewer; his precious son, Ryan; his father, Daniel J. McCarthy; his brother Kenneth Krals of Worcester; his 6 sisters, Deborah Morgan and her husband Paul of Oxford; Brenda Pastor and her husband Bob of Rutland; Cynthia Krals of Grafton; Tina Barnhill and her husband Daryn of Georgia; Tracy Greene and her husband Kevin of Worcester; and Dawn Light and her husband Danny of Sutton; and his in-laws, the Noonan Family of Palmer.
