Met at two minutes past eleven o'clock A.M. (Mr. Petruccelli in the Chair).

The Chair (Mr. Petruccelli), members, guests and employees then recited the pledge of allegiance to the flag.

Communication.

A communication from the Honorable Therese Murray, President of the Senate, announcing the resignation of Senator Marc R. Pacheco and the appointment of Senator Richard T. Moore to the Special Commission established (pursuant to Section 106 of Chapter 182 of the Acts of 2008) relative to civic engagement and learning,—was placed on file.

PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 5111) of Joseph F. Wagner (with the approval of the mayor and board of aldermen) that the city of Chicopee be authorized to convey a certain parcel of abandoned park land to David and Paula Austin,—was referred, in concurrence, to the committee on Municipalities and Regional Government.

A Bill authorizing the State Board of Retirement to grant creditable service to Robert M. Penta (House, No. 4115,— on petition),— was read and, under Senate Rule 27, referred to the committee on Ways and Means.

Relative to the notification of mammographic examinations (House, No. 2188,— on House No. 4749, in part); Establishing Moby Dick as the epic novel of the Commonwealth (House, No. 3964, changed,— on petition); Relative to the Edward Cohen plaque (House, No. 5002,— on petition); and

Relative to the charter of the town of Westborough (House, No. 4878,— on petition) [Local approval received]; and Authorizing affordable housing covenants in the town of Arlington (House, No. 4938,— on petition);

Were severally read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

Notice was received from the House announcing the following appointment:

Motion to Reconsider.

Mr. Hedlund moved that the Senate reconsider the vote by which, at a previous session, it had passed to be engrossed the House Bill authorizing the Department of Highways and the town of Kingston to exchange a certain parcel of land (see House, No. 4913); and, there being no objection, the motion prevailed.

Pending the recurring question on passing the bill to be engrossed, Mr. Panagiotakos presented an amendment striking out section 7; and inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to authorize the department of highways and the town of Kingston to exchange a certain parcel of land, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was adopted.

The recurring question on passing the bill, as amended, to be engrossed was then considered; and the bill was again engrossed, in concurrence, with the amendment.

Sent to the House for concurrence in the amendment and the amendment previously adopted by the Senate.

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows: The House Bill authorizing the town of Northborough to grant an additional alcoholic beverage license for the sale of wine and malt beverages (House, No. 4937),—was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act authorizing the town of Northborough to grant 2 additional licenses for the sale of alcoholic beverages".

There being no objection, the rules were suspended, on motion of Mr. Knapik, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act prohibiting discrimination against physical therapists and physical therapist assistants in securing medical malpractice insurance".

Mr. Downing, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

There being no objection, the rules were suspended, on motion of Mr. Hedlund, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.
