Met at two minutes past eleven o'clock A.M. (Ms. Spilka in the Chair).

The Chair (Ms. Spilka), members, guests and employees then recited the pledge of allegiance to the flag.

### Communications.

The following communications were severally read and placed on file, to wit:

A communication from the Honorable Therese Murray, President of the Senate, announcing the removal of Senator Dianne Wilkerson as Senate Co-Chair to the Special Commission established (pursuant to Subsection 16O of Section 3 of Chapter 58 of the Acts of 2006) relative to health care disparities, and the appointment of Senator Susan C. Fargo as Senate Co-Chair to the commission; and

A communication from the Comptroller of the Commonwealth (under the provisions of Section 12(a) of Chapter 7A of the General Laws) submitting the Commonwealth's Statutory Basis Financial Report (SBFR) for fiscal year ended June 30, 2008 (received Friday, October 31, 2008).

# PAPERS FROM THE HOUSE.

A message from His Excellency the Governor recommending legislation relative to validating the actions taken by the town of Webster open town meeting and establishing a charter for the town of Webster (House, No. 5133),— was referred, in concurrence, to the committee on Municipalities and Regional Government.

Notice was received from the House announcing the following appointments:

That the Speaker of the House of Representatives has appointed Representatives Donato of Medford (co-chair), Peisch of Wellesley and Kujawski of Webster to the Special Commission (under Section 97 of Chapter 173 of the Acts of 2008) to make an investigation and study of feasibility of innovative local revenue-generating measures in an effort to provide revenue relief to

municipalities; and

That the Speaker of the House of Representatives has appointed Representative Harkins of Needham to the Special Commission (under Section 112 of Chapter 182 of the Acts of 2008) to make an investigation and study of the manner in which municipalities and towns of the Commonwealth balance their fiscal year budgets.

#### Resolutions

The following resolutions (having been filed with the Clerk) were severally considered forthwith and adopted, as follows:—Resolutions (filed by Mr. Augustus) "honoring the Grafton Land Trust on its fiftieth anniversary";

Resolutions (filed by Messrs. Baddour, Downing, Hart, Moore, Tarr and Tisei and Ms. Tucker) "congratulating the Pioneer Institute on its twentieth anniversary"; and

Resolutions (filed by Mr. Morrissey) "congratulating Alice Wilkes Frame on the joyous occasion of her ninetieth birthday."

Engrossed Bill Returned by Governor With Recommendation of Amendment.

The engrossed Bill relative to the granting of certain licenses for the sale of alcoholic beverages to be drunk on the premises in the town of Wenham (see Senate, No. 2824) (which on Monday, October 20, 2008, had been laid before the Governor for his approbation), was returned to the Senate Clerk by the Governor on Thursday, October 30, 2008 at twenty-five minutes past three o'clock P.M., with a message recommending an amendment.

The message (Senate, No. 2885) was read and the Senate proceeded to reconsider the bill, in accordance with the provisions of Article LVI of the Amendments to the Constitution.

Pending action thereon, the bill was referred to the committee on Bills in the Third Reading, on motion of Mr. Tarr.

## Report of a Committee.

Mr. Downing, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill designating a certain bridge in the city of Worcester as the State Trooper Paul F. Barry Bridge Memorial Bridge (House, No. 4869).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.
