Friday, May 14, 2010.

Met according to adjournment at twelve o'clock noon (Mr. Donnelly in the Chair).

Engrossed Bill — Laid Before the Governor.

An engrossed Bill making appropriations for the fiscal year 2010 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 4670) (which originated in the House), having been passed to be enacted and signed by the President on Thursday, May 13, 2010,— **was laid before the Governor for his approbation on Friday, May 14, 2010.**

Petitions.

By Mr. Panagiotakos, for the committee on Ways and Means, that the House Bill establishing a sick leave bank for Stephen R. Fratalia, an employee of the Trial Court (House, No. 4576),-- **ought to pass.**

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

By Mr. Panagiotakos, for the committee on Ways and Means, under the provisions of Senate Rule 19, a Committee Bill to promote cost containment, transparency and efficiency in the provision of quality health insurance for individuals and small businesses (Senate, No. 2437),-- was read.

Order Adopted.

Mr. Panagiotakos offered the following order:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the Senate Committee Bill to promote cost containment, transparency and efficiency in the provision of quality health insurance for individuals and small businesses (Senate, No. 2437) shall be placed in the Orders of the Day for a second reading on Tuesday, May 18, 2010.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 12:00 Noon on Monday, May 17, 2010. All such amendments shall be second-reading amendments but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

Under the rules, referred to the committee on Ethics and Rules.

Subsequently, Mr. Berry, for the said committee, reported, recommending that the order ought to be adopted.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the order was considered forthwith and adopted.

The bill (Senate, No. 2437) was then placed in the Orders of the Day for Tuesday, May 18, 2010, for a second reading.

Order Adopted.
