JOURNAL OF THE SENATE.

Wednesday, June 2, 2010.

Met at one minute past eleven o'clock A.M. (Mr. Hart in the Chair).

The Chair (Mr. Hart), members, guests and employees then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Hart) introduced, seated in the balcony, the fourth grade class of the Parker Avenue School of Dracut. They were accompanied by Anne Ziaja of the Legislative Education Office. The Senate welcomed them with applause and they withdrew from the balcony after the session.

Report of a Committee.

By Ms. Spilka, for the committee on Economic Development and Emerging Technologies, on Senate, Nos. 192, 193, 194, 195, 197, 198, 199, 201, 202, 204, 206 and 2041, an Order relative to authorizing the joint committee on Economic Development and Emerging Technologies to make an investigation and study of certain current Senate documents relative to economic development (Senate, No. 2467);

Referred, under Joint Rule 29, to the committee on Rules of the two branches acting concurrently.

By Mr. Panagiotakos, for the committee on Ways and Means, that the Senate Bill releasing certain land in Brimfield from the operation of an agricultural preservation restriction (Senate, No. 2221),-- **ought to pass.**
There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: “An Act releasing certain land in the town of Brimfield from an agricultural preservation restriction”.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed.
Sent to the House for concurrence.

Mr. Berry, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill relative to the enhancement of public safety (Senate, No. 911).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time.

Mr. Baddour presented an amendment substituting a new draft entitled “An Act strengthening the laws related to the regulation of explosives” (Senate, No. 2468).
