JOURNAL OF THE SENATE.

Tuesday, June 23, 2009.

Met at twenty-one minutes past eleven o'clock A.M. (Mr. Tolman in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Tolman), members, guests and employees then recited the pledge of allegiance to the flag.

Communication.

A communication from the Honorable Therese Murray, President of the Senate, announcing the appointment of Senator Anthony Petrucci to the Special Commission established (under Section 87 of Chapter 169 of the Acts of 2008) to make an investigation and study of burning construction and demolition waste,-- **was placed on file.**

Petitions.

By Mr. Pacheco, a petition (accompanied by bill, Senate, No. 2092) of Marc R. Pacheco (with the approval of the mayor and city council) for legislation relative to a certain parcel of land in the city of Taunton [Local approval received];

Resolutions.

Petition.

Engrossed Bill.

An engrossed Bill relative to employees of the town of Westborough (see House, No. 3796) (which originated in the House), **having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Tolman) and laid before the Governor for his approbation.**
