### JOURNAL OF THE SENATE.

*Wednesday, July 8, 2009.*

Met at two minutes past eleven o'clock A.M. (Mr. McGee in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. McGee), members, guests and employees then recited the pledge of allegiance to the flag.

### PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 1884) of Bill Bowles, Scott P. Brown and Elizabeth A. Poirier (with the approval of the mayor and municipal council) that Ronald M. Churchill be authorized to continue to hold the position of chief of the fire department of the city of Attleboro, notwithstanding the maximum age requirement,-- **was referred, in concurrence, to committee on Public Service.**

A Bill relative to the Dukes County Land Bank (House, No. 4043,- on petition),-- **was read and, under Senate Rule 26, referred to the committee on Ethics and Rules.**

A Bill relative to the Falmouth Historic District Commission (House, No. 4101,- on petition) [Local Approval received], -- **was read and, under Senate Rule 26, placed in the Orders of the Day for the next session.**

*Emergency Preamble Adopted.*

An engrossed Bill establishing a sick leave bank for Angela N. Wilson, an employee of the Department of Youth Services (see House, No. 613), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

**The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment**

*Report of Committees.*

Mr. Berry, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill relative to the Leino Water District (Senate, No. 2068).

**There being no objection, the rules were suspended, on motion of Mr. Brown, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed (its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act relative to the Leino Park Water District. Sent to the House for concurrence.**

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of James B. Eldridge, Viriato Manuel deMacedo, David P. Linsky and Susan C. Tucker for legislation relative to voting equipment.

**Senate Rule 36 was suspended, on motion of Mr. Brown, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Election Laws.**

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Michael W. Morrissey for legislation to expand certain automobile insurance coverage options.

**Senate Rule 36 was suspended, on motion of Mr. Brown, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Financial Services.**

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of James B. Eldridge, Jennifer L. Flanagan, Jennifer M. Callahan, James Arciero and Jennifer Benson for legislation to establish a state emergency response fund.

**Senate Rule 36 was suspended, on motion of Mr. Brown, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Safety and Homeland Security.**

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 7B be suspended on the Senate petition of Steven M. Brewer and Christopher J. Donelan for legislation to exempt part-time call firefighters in the town of Athol from the civil service law [Local approval received].

**Senate Rule 36 was suspended, on motion of Mr. Brown, and the report was considered forthwith. Joint Rule 7B was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service.**

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of James E. Timilty for legislation to establish a distinctive license plate supporting public schools.

**Senate Rule 36 was suspended, on motion of Mr. Brown, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Transportation.**
