JOURNAL OF THE SENATE.

Thursday, October 29, 2009.

Met at five minutes past eleven o'clock A.M. (Mr. Tolman in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Tolman), members, guests and employees then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the President handed the gavel to Mr. Joyce for the purpose of an introduction. Mr. Joyce then introduced the eighth grade class from the Fenn School in Concord, Massachusetts. The class was led by Lucas O'Brien, the nephew of former Senator John O'Brien and Senator Joyce. The Senate welcomed them with applause and they withdrew from the Chamber.

Reports of Committees.

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day, and considered as follows: The House Bill relative to the tenure of the city clerk, city collector and city engineer in the city of Revere (House, No. 3708, amended),—was read a third time and passed to be engrossed, in concurrence.

Report of a Committee.

The Senate Bill designating a certain bridge in the city of Fall River and the town of Somerset as the Veterans Memorial Bridge (Senate, No. 2124).

The rules were suspended, on motion Mr. Tisei, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

PAPER FROM THE HOUSE.

The House Bill authorizing the town of Norton to transfer certain park land (House, No. 4136),— came from the House with endorsement that the House had NON-concurred in the Senate amendments striking out section 5 and inserting in place thereof the following 2 sections:—

"SECTION 5. If the land conveyed pursuant to section 1 ceases to be used for the purposes described in said section 1, the land shall revert to the town of Norton to be used for conservation purposes.

SECTION 6. This act shall take effect upon its passage.".

The rules were suspended, on motion of Mr. Tisei, and, on further motion of the same Senator, the Senate receded from its amendments.

Reports of Committees.

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Geno Orsogna for legislation relative to the licensing of businesses that repair televisions and radios. Senate Rule 36 was suspended, on motion of Mr. Tisei, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Consumer Protection and Professional Licensure.

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Colby Taylor for legislation relative to unmarried couples with children.

Senate Rule 36 was suspended, on motion of Mr. Tisei, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on the Judiciary. Severally sent to the House for concurrence.

Establishing a sick leave bank for Mary Markley, an employee of the Trial Court (see House, No. 4233); and Authorizing the town of Winchester to grant 5 licenses for the sale of all alcoholic beverages to be drunk on the premises of certain restaurants (see House, No. 4259, amended).

Ordered, That when the Senate adjourns today, it adjourn to meet again on Monday next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.

Adjournment in Memory of Craig Haberland.

The Senator from Essex and Middlesex, Mr. Tarr, requested that when the Senate adjourns today, it adjourn in memory of Craig Haberland.

Craig Haberland was born in Winthrop in 1940, and moved to Gloucester soon after, where he lived for most of his life. He attended public school in Gloucester, graduating from Gloucester High School in 1958 and the Lowell Technological Institute in 1962. After graduating, he was a general contractor for J.W. Gray in Gloucester for fifteen years before buying the company and operating it until 1986. Mr. Haberland was also the building inspector for the city of Gloucester for fourteen years before his retirement in 2000.

Mr. Haberland enjoyed woodworking, cross-country skiing, biking, boating on his Mako, and bluefishing on Cape Ann.

On Sunday, October 25, 2009, Craig Haberland passed away. He is survived by his wife of 44 years, Marjorie Haberland; two daughters; and many family members, including William Haberland, his nephew, who is the chief of staff to Senator Robert O'Leary. He will be missed.
