Met at five minutes past eleven o'clock A.M. (Mr. Tolman in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day, and considered as follows: The House Bill authorizing the abatement of certain property tax assessments in the town of Lexington (House, No. 1135),— was read a third time.

Pending the question on passing the bill to be engrossed, in concurrence, Mr. Donnelly presented an amendment striking out all after the enacting clause and inserting in place thereof the following text:—

"SECTION 1. Notwithstanding sections 2A, 2D, 18 and 38 of chapter 59 of the General Laws or any other general or special law to the contrary, the town of Lexington, acting by and through its board of assessors, shall abate or refund a portion of the taxes assessed for fiscal year 2009 on any real estate that decreased in assessed valuation by over 50 per cent as the result of fire or natural disaster that occurred during fiscal year 2009. The post-fire or post-natural disaster valuation shall be considered the assessed valuation of the property as of January 1, 2008 for purposes of assessing taxes for the fiscal year beginning on July 1, 2008.

SECTION 2. Applications for an abatement or refund shall be filed with the Lexington Board of Assessors not later than January 1, 2011.

SECTION 3. This act shall take effect upon its passage."

The amendment was adopted.

The bill, as amended, was then passed to be engrossed, in concurrence, with the amendment. Sent to the House for concurrence in the amendment.

The bill was signed by the Acting President (Mr. Tolman) and sent to the House for enactment.
