### JOURNAL OF THE SENATE

*Wednesday, March 9, 2011.*

Met at one minute past eleven o'clock A.M. (Mr. Petruccelli in the Chair).

The Chair (Mr. Petruccelli), members, guests and employees then recited the pledge of allegiance to the flag.  
Petitions.

The following petition, having been timely filed by five o'clock P.M., on Friday, January 21, 2011, was considered, as follows:—  
Ms. Petruccelli presented a petition (accompanied by bill, Senate, No. 1872) (subject to Joint Rule 9) of Anthony Petruccelli for legislation to develop the North Point area of the city of Cambridge,— **and the same was transmitted, under the provisions of Section 5 of Chapter 3 of the General Laws, to the Secretary of State.**
