Monday, April 11, 2011.

Met according to adjournment at eleven o'clock A.M. (Mr. McGee in the Chair) (having been appointed by the President, under authority conferred in Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. McGee), members, guests and employees then recited the pledge of allegiance to the flag.

Petitions.

Petitions were severally presented and referred, as follows:

By Ms. Fargo, a petition (subject to Joint Rule 12) of Susan C. Fargo, Barry R. Finegold, Jennifer L. Flanagan and other members of the General Court for the adoption of resolutions memorializing the Congress of the United States to observe an annual two minute moment of silence on Veterans Day to honor those who have served in the United States Armed Forces.;

By Ms. Murray, a petition (subject to Joint Rule 12) of Therese Murray for legislation to establish a sick leave bank for Christine S. Drew, an employee of the Trial Court.;

By Mr. Pacheco, a petition (subject to Joint Rule 12) of Marc R. Pacheco and Jay Kaufman for legislation relative to the enrollment into the state retirement system of higher education employees in the optional retirement plan; Severally, under Senate Rule 20, to the committees on the two branches, acting concurrently.

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill authorizing the appointment of Drew Lonergan as a police officer in the town of Bourne (see Senate, No. 1885), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 2 to 0. The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment. Subsequently, the bill, which originated in the Senate, came from the House with the endorsement that it had been

Subsequently, the bill, which originated in the Senate, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Mr. McGee) and laid before the Governor for his approbation.
