JOURNAL OF THE SENATE.

Thursday, April 19, 2012.

Met at three minutes past eleven o'clock A.M. (Ms. Spilka in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Spilka), members, guests and staff then recited the pledge of allegiance to the flag.

## Distinguished Guests.

There being no objection, the Chair (Ms. Spilka) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, a high school class from Grenaa Gymnasium (High School) in Denmark. The class is a social/political studies class, interested in learning about United States history and government. The class was accompanied by their teachers, Stine Sorensen and Karsten Vilholm.

Adjournment in Memory of Nathaniel "Nate" Snow Downing

The Senator from Berkshire, Hampshire and Franklin, Mr. Downing, moved that when the Senate adjourns today, it adjourn in memory of his brother, Nathaniel "Nate" Snow Downing.

Nathaniel "Nate" Snow Downing died suddenly on April 13, 2012.

Nate will be remembered as a bright and charismatic young man with a passion for politics and for life. He was a 2003 graduate of St. Joseph's Central High School in Pittsfield, where he excelled in academics while also participating in music, drama, and Model Congress. A 2007 magna cum laude graduate of Providence College, Nate studied Political Science and American Studies. He attended the 2004 Democratic Convention in Boston, interned at the Supreme Court in Washington, D.C., and worked on his brother Benjamin's successful bid for State Senate in 2006. After graduating from Providence College, Nate joined the Attorney General's office as an investigator where he worked until 2009.

Nate entered New England School of Law in 2009 to fulfill a lifelong dream of becoming a lawyer. He earned the honor of serving on the Law Review as an associate in his second year and an executive articles editor in his third year. While in school he also worked as a legal analyst for Blue Cross Blue Shield. Nate recently began volunteering for Joseph Kennedy III's congressional campaign, relishing an opportunity to spend a day driving the candidate.

Nathaniel Snow Downing was born September 15, 1985, in Pittsfield, son of Pamela Brackett Downing and the late Berkshire County District Attorney Gerard Downing. In addition to his mother of Pittsfield, he leaves two brothers, State Senator Benjamin Downing of Pittsfield and Nicholas Downing of Boston, and a sister, Margaret Downing of Washington, D.C.. He also leaves many beloved aunts, uncles, and cousins. His grandparents, John and Gertrude Downing of Pittsfield and Frank and Shirley Brackett of Weymouth, predeceased him.

Accordingly, as a mark of respect to the memory of Nathaniel "Nate" Snow Downing, at twenty-one minutes past eleven o'clock A.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
