## PAPERS FROM THE HOUSE

Emergency Preamble Adopted.

An engrossed Bill relative to oversight of private occupational schools (see House, No. 3625, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Hart) and sent to the House for enactment.

Engrossed Bill.

An engrossed Bill amending the charter of the town of Harwich (see House, No. 3503, changed) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Hart) and laid before the Governor for his approbation.

Recess.

There being no objection, at twenty-four minutes before twelve o'clock noon, the Chair (Mr. Hart) declared a recess subject to the call of the Chair; and, at three minutes past twelve o'clock noon, the Senate reassembled, Ms. Flanagan in the Chair.

Report of a Committee.

By Mr. Brewer, for the committee on Ways and Means, that the House Bill making appropriations for the fiscal year two thousand thirteen for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 4101),-- ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 4.

Under the provisions of an order previously adopted by the Senate, the bill was placed in the Orders of the Day for Wednesday, May 23, 2012, for a second reading, with the amendment pending.
