### JOURNAL OF THE SENATE.

*Thursday, August 2, 2012.*

Met at one minute past eleven o'clock A.M. (Ms. Donoghue in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Donoghue), members, guests and staff then recited the pledge of allegiance to the flag.

*Distinguished Guests.*

There being no objection, the Chair (Ms. Donoghue) introduced, in the rear of the Chamber, Mary Ann O'Brien and Dottie Chandonett from Lowell. They were on a tour of the State House for the first time and learning about the different aspects of state government. The Senate welcomed them with applause and they withdrew from the Chamber.

*Report of a Committee.*

By Mr. Donnelly, for the committee on State Administration and Regulatory Oversight, on Senate, Nos. 1563, 1575 and 1576, an Order relative to authorizing the joint committee on State Administration and Regulatory Oversight to make an investigation and study of certain current Senate documents relative to public records issues (Senate, No. 2412);

Authorizing the appointment of Amy McCarthy as a police officer in the town of North Andover, notwithstanding the maximum age requirement (House, No. 3835,-- on petition) [Local approval received];

Authorizing the town of Sharon to issue licenses to certain establishments for the sale of all alcoholic beverages to be drunk on the premises (House, No. 4163,-- on petition) [Local approval received]; and

Authorizing the city of Medford to grant additional licenses for the sale of all alcoholic beverages to be drunk on the premises (House, No. 4246,-- on petition) [Local approval received];

### *Reports of Committees.*

Mr. Berry, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill designating a certain bridge in the city of Lowell as the Gentz Brothers Memorial Bridge (House, No. 3951).

**There being no objection, the rules were suspended, on motion of Mr. Pacheco, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

By Mr. Berry, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Therese Murray and Thomas Calter for legislation to establish a sick leave bank for Ellen Grady, an employee of the Department of Public Health.

**Senate Rule 36 was suspended, on motion of Mr. Hedlund, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service.**
