JOURNAL OF THE SENATE.

Monday, December 19, 2011.

Met at two minutes past eleven o'clock A.M. (Mr. Donnelly in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Donnelly), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Donnelly) handed the gavel to Mr. Ross for the purpose of an introduction. Mr. Ross then introduced, in the rear of the Chamber, Erika O'Brien, Jodi Cullity and Anna Saulnier. They are students at King Philip Middle School and are members of the DECA club which is known for teaching entrepreneurship and leadership to its students. The Senate welcomed them with applause and they withdrew from the Chamber.

There being no objection, the Chair (Mr. Donnelly) handed the gavel to Mr. Finegold for the purpose of an introduction. Mr. Finegold then introduced, in the rear of the Chamber, the Division 1 MIAA Championship Girls Swim Team from Andover High School. They have won this title 12 out of the past 13 years. The Senate applauded their accomplishments and they withdrew from the Chamber.

The Honorable Bruce E. Tarr, Senate Minority Leader, has announced the following appointments to various special commissions and committees:

Senator Bruce E. Tarr to the Special Commission established (pursuant to Section 59 of Chapter 176 of the Acts of 2011) to make an investigation and study of all aspects of the ordinary and accidental disability provisions of the Massachusetts contributory retirement system as well as the provisions of injured on duty benefits and presumptions for public employees contained in the General Laws:

Senator Richard J. Ross to the Special Commission established (pursuant to Section 56 of Chapter 176 of the Acts of 2011) to make an investigation and study of the Massachusetts public employees' pension classification system;

Senator Richard J. Ross to the Special Commission established (pursuant to Chapter 85 of the Acts of 2011) to make an investigation and study on the police career incentive payment program; and

Senator Richard J. Ross to the Special Commission established (pursuant to Section 194 of Chapter 68 of the acts of 2011) to identify women who have made an extraordinary contribution to the Commonwealth and offer recommendations on providing recognition for these women in the State House.

Authorizing the town of Natick to grant certain licenses for the sale of wines and malt beverages to be drunk on the premises (House, No. 3725, amended-- on House, No. 3561) [Local approval received on House, No. 3561]; and

Emergency Preamble Adopted.

An engrossed Bill establishing a special commission to study electronic benefit transfers (see House, No. 3773, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,—was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0. The bill was signed by the Acting President (Mr. Donnelly) and sent to the House for enactment.

Engrossed Bills.

An engrossed Bill amending the charter of the town of Winchendon (see Senate, No. 1966) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Donnelly) and laid before the Governor for his approbation.

An engrossed Bill establishing a special commission to study electronic benefit transfers (see House, No. 3773, amended) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be re-enacted and signed by the Acting President (Mr. Donnelly) and again laid before the Governor for his approbation.
