Monday, December 24, 2012.

Met at five minutes past eleven o'clock A.M. (Mr. Petruccelli in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Petruccelli), members, guests and staff then recited the pledge of allegiance to the flag.

Report of a Committee.

A Bill further regulating the granting of temporary licenses for the sale of wine at certain auctions (House, No. 4536,-- on House, No. 1883),-- was read.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act further regulating the granting of temporary licenses for the sale of wines at certain auctions."

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered, as follows: The Senate Bill relative to the budget review process in the town of Greenfield (Senate, No. 2426),-- was read second time. Pending the question on ordering the bill to a third reading, Mr. Rosenberg presented an amendment substituting a new draft entitled "An Act amending the charter of the city known as the town of Greenfield to establish a mayor's task force against domestic violence" (Senate, No. 2480).

The amendment was adopted.

The bill (Senate, No. 2480) was then ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.

Motion to Take a Matter Out of the Orders of the Day.

The Chair (Mr. Petruccelli) asked unanimous consent to take the Senate Bill relative to process piping (Senate, No. 2478) out of the Orders of the Day for consideration,-- but objection was made thereto by Mr. Tarr.

Sent to the House for concurrence in the amendment.

The House Bill relative to annual immunization against influenza for children (House, No. 3948),-- was read a third time. Pending the question on passing the bill to be engrossed, Mr. Rodrigues presented an amendment in section 1, by inserting after the word "all", in line 3, the following words:- "elementary and".

The amendment was adopted.

Ms. Spilka, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill relative to residents of continuing care retirement communities (Senate, No. 2139).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

Ms. Spilka, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill relative to the prevention of falls in the elderly community (House, No. 180).

Adjournment in Memory of C. Bruce Brown.

The Senator from Essex and Middlesex, Mr. Tarr, moved that when the Senate adjourns today, it adjourn in memory of C. Bruce Brown, a longtime Newburyport resident and former city councilor, who passed away on December 20, 2012 at Country Manor Nursing Home in Newburyport at the age of 75.

Born in Olean, New York on June 9, 1937, Mr. Brown was the son of the late Woodrow and Doris (Lanphere) Brown and was a graduate of Oswayo High School in Shinglehouse, Pennsylvania. He served in the United States Air Force from August 9, 1955 until his honorable discharge on October 8, 1959, and was stationed at Pease Air Force Base in Portsmouth, New Hampshire. He later attended the University of New Hampshire.

Mr. Brown was a Special Education teacher and basketball coach at Amesbury High School. In addition to selling insurance for the Prudential Insurance Company for 25 years, he also established his own marketing company, Atlantic Advertising Media, which worked primarily with YMCAs throughout New England, New York and Pennsylvania. He also opened a country store in Salisbury and ran a tourist boat, the Sabino, on the Merrimack River.

Mr. Brown served as the Ward 2 city councilor in Newburyport from 1970-1973, and later served as the Ward 1 city councilor from 1992-2001, representing the residents of Plum Island. He was president of the council from 1972-1973, and led the council again for a brief period in 1997. He also made an unsuccessful run for the Massachusetts House of Representatives in 1992.

An active member of the Newburyport community, Mr. Brown was Chairman of the 1982 Yankee Homecoming; Director of the Haverhill Y.M.C.A.; a longtime advocate and supporter of the Jimmy Fund; and a member of the Benevolent Protective Order of Elks, the Newburyport Lions Club and St. John's Lodge, A.F. & A.M. of Newburyport. He also served as a volunteer on many boards and commissions, including The Salvation Army; the Newburyport Housing Authority; The Olde Newbury Historical Society; Friends of Plum Island Lighthouse; and the Newburyport Waterfront Trust.

In addition to his wife, Peggy L. (Kennedy) Brown of Newburyport, Mr. Brown is also survived by three children, including U.S. Senator Scott P. Brown and his wife Gail of Wrentham; Robyn L. Brown of Scarborough, Maine; and Bruce Browne and his wife Michelle of Wolcott, Connecticut. He is also survived by two step-children, Tracy Harrington and her husband Christian of Amesbury and Todd Harrington and his wife Amy of Bennington, Vermont; a sister, Linda L. Dixon of Newark, New Jersey; eight grandchildren, including Joshua Heath and his wife Jennifer of Erie, Pennsylvania; Emily Heath of Midvale, Utah; Kyle Turin; Ayla Brown of Nashville, Tennessee; Arianna Brown of Maryland; Gabriella Browne of New Hampshire; Parker and

Devin Browne of Wolcott, Connecticut; and Taylor Harrington of Bennington, Vermont; as well as several nieces, nephews, cousins, colleagues and dear friends.

Accordingly, as a mark of respect to the memory of C. Bruce Brown, at quarter before twelve o'clock noon, on motion of Mr. Tarr, the Senate adjourned to meet again on Thursday at eleven o'clock A.M.
