### JOURNAL OF THE SENATE.

*Monday, June 9, 2014.*

Met at two minutes past eleven o'clock A.M. (Mr. Petrucci in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Students from the Boyden Elementary School in Walpole led the Chair (Mr. Petrucci), members, guests and staff in the recitation of the pledge of allegiance to the flag.

#### *Petitions.*

Petitions were severally presented and referred, as follows:

By Mr. Donnelly, a petition (accompanied by bill, Senate, No. 2177) of Kenneth J. Donnelly, Sean Garballey and David M. Rogers (by vote of the town) for legislation to increase the number of all alcohol licenses for restaurants in the town of Arlington [Local approval received];

**Under Senate Rule 20, to the committee on Consumer Protection and Professional Licensure.**

By Mr. Tarr, a petition (accompanied by bill, Senate, No. 2178) of Bruce E. Tarr and Leonard Mirra (by vote of the town) for legislation to allow certain senior support staff members of Protection Fire Co. No. 1 of Byfield to continue to serve beyond the age of 65 [Local approval received];

**Under Senate Rule 20, to the committee on Public Service.**

**Severally sent to the House for concurrence.**

#### *Reports of Committees.*

By Mr. Joyce, for the committee on Bonding, Capital Expenditures and State Assets, that the House Bill relative to the expansion of the Boston Convention and Exhibition Center (House, No. 4111),-- **ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of the Senate document numbered 2180;**

**Under Senate Rule 27, referred to the committee on Ways and Means, with the amendment pending.**

By Ms. Donoghue, for the committee on Community Development and Small Business, on Senate Nos. 73, 74, 75, 77, 78 and 79, an Order relative to authorizing the joint committee on Community Development and Small Business to make an investigation and study of certain current Senate documents relative to community development and small business issues (Senate, No. 2179);

**Referred under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.**

By Mr. Kennedy, for the committee on Consumer Protection and Professional Licensure, on petition (accompanied by bill Senate, No. 91), a Bill relative to special one-day licenses to sell or dispense alcoholic beverages (Senate, No. 2172);

**Read and, under Senate Rule 27, referred to the committee on Ways and Means.**

#### *Committees Discharged*

Mr. Rosenberg, for the committees on Rules of the two branches, acting concurrently, reported, asking to be discharged from further consideration:

Of the Senate Order relative to authorizing the joint committee on Higher Education to make an investigation and study of certain current Senate documents relative to higher education issues (Senate, No. 2168); and

Of the Senate Order relative to authorizing the joint committee on Veterans and Federal Affairs to make an investigation and study of certain current Senate and House documents relative to veterans and federal affairs issues (Senate, No. 2167);

**And recommending that the same severally be referred to the committee on Ethics and Rules.**

**Under Senate Rule 36, the reports were severally considered forthwith and accepted.**

#### **PAPERS FROM THE HOUSE**

A Bill providing for the preservation and improvement of land, parks and clean energy in the Commonwealth (House, No. 4150-- on House, No. 3332),-- **was read and, under Senate Rule 26C, referred to the committee on Bonding, Capital Expenditures and State Assets.**

A Bill establishing a sick leave bank for Richard Brophrey, an employee of the Department of Unemployment Assistance (House, No. 4116,-- on petition),-- **was read and, under Senate Rule 27, referred to the committee on Ways and Means.**

A Bill relative to certain judicial procedures in the Superior Court (House, No. 4123,-- on House, No. 1211),-- **was read and, under Senate Rule 26, referred to the committee on Ethics and Rules.**

#### *Matters Taken Out of the Orders of the Day.*

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The House Bill relative to a certain parcel of land in the town of Stow (House, No. 3935),-- **was read a third time and passed to be engrossed, in concurrence.**

The House Bill establishing the position of an appointed town treasurer-collector in the town of Somerset (House, No. 4027),-- **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

#### *Reports of Committees.*

By Mr. Brewer, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Kyle Melvin, an employee of the Department of Correction (Senate, No. 2155),-- **ought to pass.**

**There being no objection, the rules were suspended, on motion of Mr. Donnelly, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed.**  
**Sent to the House for concurrence.**

By Mr. Brewer, for the committee on Ways and Means, that the House Bill establishing a sick leave bank for Anne Federico, an employee of the Department of Public Health (House, No. 3958),-- **ought to pass.**

**There being no objection, the rules were suspended, on motion of Mr. Donnelly, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

Mr. Rosenberg, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill relative to breast cancer early detection (House, No. 3733) (the committee on Ethics and Rules recommending that the bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2181).

**There being no objection, the rules were suspended, on motion of Mr. Donnelly, and the bill was read a second time and was amended, as recommended by the committee on Ethics and Rules.**

**The bill was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment.**

**Sent to the House for concurrence in the amendment.**

#### **PAPERS FROM THE HOUSE.**

A petition (accompanied by bill, House, No. 4159) of Claire D. Cronin, Thomas P. Kennedy and others relative to photographs used for driver's licenses and identification cards,-- **was referred, in concurrence, under suspension of Joint Rule 12, to the committee on Transportation.**

#### *Engrossed Bills.*

The following engrossed bills (the first of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Petruccelli) and laid before the Governor for his approbation, to wit:

Providing for recall elections in the town of Lancaster (see Senate, No. 2040, changed and amended); and  
Relative to continuing education requirement for insurance producers (see House, No. 880); and  
Relative to Quincy College (see House, No. 3814, amended).

*Order Adopted.*

On motion of Mr. Donnelly,--

*Ordered*, That when the Senate adjourns today, it adjourn to meet again tomorrow next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.
