Tuesday, June 18, 2013.

Met according to adjournment at one o'clock P.M. (Mr. Richard T. Moore in the Chair).

Communication.

Communication from the Executive Office of Public Safety, Department of Fire Services (under the provisions of Section 3b of Chapter 7 of the General Laws) submitting notice of a proposed fee being proposed as part of 801 CMR 402 (527) to defray administrative costs of the newly created Fire Prevention Regulations Appeals Board,-- **was placed on file.**

Petitions.

Petitions were severally presented and referred, as follows:

By Mr. Tarr, a petition (accompanied by bill, Senate, No.1801) of Bruce E. Tarr and Bradford Hill (by vote of the town) for legislation to provide for the recall of elected officials in the town of Ipswich [Local approval received];

Under Senate Rule 20, to the committee on Election Laws.

By Ms. Murray, a petition (accompanied by bill, Senate, No.1802) of Therese Murray, Timothy R. Madden and David T. Vieira (by vote of the town) for legislation relative to the issuance of bonds or notes by the town of Falmouth [Local approval received];

Under Senate Rule 20, to the committee on Municipalities and Regional Government.

There being no objection, at one minute past one o'clock P.M., the Chair (Mr. Richard T. Moore) declared a recess subject to the call of the Chair; and, at ten minutes past three o'clock P.M., the Senate reassembled, the President in the Chair.

PAPER FROM THE HOUSE.

A Bill supplementing certain existing capital spending authorizations (printed in House, No. 3331, amended,-- being a message from his Excellency the Governor),-- **was read.**

PAPER FROM THE HOUSE
Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Kristen Giunta, an employee of the Department of Correction (see House, No. 3441), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 24 to 0. The bill was signed by the President and sent to the House for enactment.**

Moment of Silence.

At the request of the President, members, guests and staff stood in a moment of silence and reflection to the memory of Private First Class Christopher P. Dona, U.S. Army Ranger, from Dudley, Massachusetts.

Adjourn In Memory of PFC Christopher P. Dona of Dudley

The Senator from Worcester and Norfolk, Mr. Richard T. Moore, moved that when the Senate adjourns today it adjourn in memory of Private First Class Christopher P. Dona, U.S. Army Ranger, from Dudley, Massachusetts.

Private First Class Dona, just 21 years old, was killed on June 13th, 2013 as a result of a tragic accident during parachute training exercises in Southeast Georgia.

PFC Dona served honorably in the 1st Battalion of the 75th Ranger Regiment based at Hunter Army Airfield in Savannah, Georgia. He was a combat veteran who returned last month from his first deployment in Afghanistan. During his year and a half of service, PFC Dona received the Parachutist Badge, Expert Infantryman's Badge, and Army Expert Rifle Marksmanship Qualification Badge, along with five medals and the Army Service Ribbon. The Army will award him the Army Commendation Medal posthumously.

Lieutenant Colonel Robert J. Harman, the battalion commander stated “Chris was an excellent ranger who consistently displayed great courage and strength — a true warrior. He was the kind of Ranger everyone wants by their side in a tough situation. Chris was the epitome of what we expect of Rangers – a quiet professional with unmatched selfless service.”

PFC Dona was frequently on the honor roll at Shepherd Hill Regional High School. He enlisted in the Army in early 2012, and was a highly regarded member of the Shepherd Hill Regional High School class of 2010. In high school, he participated in both cross country and track as well as football, and was described by school officials as “a respectful, pleasant young man who had a genuine concern for others.”

Paul Dona said his son was an all-star football player and never drank or used drugs, stating that his son, “was a good kid and a smart kid.” PFC Dona’s survivors include his parents, Paul and Maryann Dona, his sister, Melissa; and his brother, Brian.
