Adjournment in Memory of Ann M. McGee

The Senator from Essex, Mr. McGee moved that when the Senate adjourns today it do so as a mark of respect to the memory of his mother, Mrs. Ann M. McGee.

Mrs. Ann M. McGee, of Danvers, formerly of Lynn, died peacefully surrounded by her family on December 6, 2013, after a long battle with Parkinson's disease. She was the former wife of the late Honorable Thomas W. McGee, former Speaker of the Massachusetts House of Representatives. Ann was born in Everett, and was the daughter of the late Anthony and Josephine Sorrenti. She was a resident of Lynn for most of her life, before moving to Danvers three years ago. She was a graduate of Everett High School, Class of 1943. After her children were grown, she returned to work at Vogue Apparel and later Brooks Brothers, and loved nothing more than to share her keen sense of style with a neophyte.

Ann's true devotion was raising her family. She enjoyed spending time with her grandchildren and attending the kid's games and different events and activities. Ann loved entertaining, was an excellent cook, and you could be assured that there was a pot of sauce, or a soup simmering on the stove.

She read the newspaper daily and loved to comment on current affairs, and her political insights were more astute than the Gallup poll - any politician that managed to get her approval was well on the way to victory. She was elegant, generous and loving, and fought valiantly against the indignities of Parkinson's to maintain her unique style and grace.

She was the devoted mother of State Senator Thomas M. McGee and his wife, Maria, of Lynn, Shawn P. McGee and his wife, Sheryl, of Georgetown, Colleen McGee Kavanaugh and her husband, Gerry Kavanaugh of New Bedford and Alexandria, Virginia, and her devoted son and caregiver, Michael McGee of Danvers; loving grandmother of 8 grandchildren and doting great-grandmother of 6; as well as dear sister of the late Josephine Sorrenti, Annette "Bebe" DeLuca, Anthony Sorrenti, Lillian Porcaro, Thomas, Frank and John Sorrenti, and Mary Wood. Ann was also loved by several nieces and nephews.
