

JOURNAL OF THE SENATE.

Monday, March 18, 2013.

Met at four minutes past eleven o'clock A.M (Mr. Donnelly in the Chair).

The Chair (Mr. Donnelly), members, guests and staff then recited the pledge of allegiance to the flag.

Petition.

Petitions were severally presented and referred, as follows

By Ms. Candaras, a petition (subject to Joint Rule 12) of Gale D. Candaras for legislation to establish a sick leave bank for Irene Archambault, an employee of the Trial Court; and

A. Scott Leavitt of Rowley passed away on Thursday, March 7, 2013 following a battle with cancer.

Scott most recently was the Tree Warden for the town of Rowley, and for the past 20 years the town's Highway Surveyor. Scott was educated in local schools, and then served for ten years in the National Guard. He was a proud and longtime member of Rowley Veteran's Association.

Scott is survived by his wife Lea Ann (Buckley) Leavitt of Rowley, four children, two brothers, two sisters, two grandchildren and a large extended family.
