Thursday, March 27, 2014.

Met at three minutes past eleven o'clock A.M. (Ms. Donoghue in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Donoghue), members, guests and staff then recited the pledge of allegiance to the flag.

Engrossed Bill.

An engrossed Bill relative to veterans' allowances, labor, outreach and recognition (see Senate, No. 2052) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Ms. Donoghue) and laid before the Governor for his approbation.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 2:00 P.M., on Friday, March 28, 2014. All such amendments shall be second-reading amendments to the recommended Senate Ways and Means new text (Senate, No. 2073) but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

Subsequently, $\dot{M}r$. Rosenberg, for the said committee on Ethics and Rules, reported, recommended, that the order ought to be adopted.

The rules be suspended, on motion of Mr. Tarr and the order was considered forthwith.

Pending the question on adoption of the order, Mr. Tarr moved that the order be amended by striking out "2:00 P.M." and inserting in place thereof the following: "12:00 noon".

The amendment was adopted.

The order, as amended was then adopted.

The bill was placed in the Orders of the Day for Thursday, April 3 for a second reading with the amendment pending.

Adjourn In Memory of Michael J. Vendetti

The Senator from Worcester and Norfolk, Mr. Richard T. Moore, moved that when the Senate adjourns today, it do so in memory of Michael J. Vendetti of Dudley.

Michael J. Vendetti of Dudley, a former professor, coach and athletic director at Nichols College, died on Thursday, March 20, 2014

Mr. Vendetti served as an Associate Professor and Director of Physical Education at Nichols College from 1962 to 1975. He then became the Director of Athletics at Nichols from 1975 to 1986, when he retired.

As a football coach, he began as an assistant at Leominster High School, proceeded to become a line coach and counselor for players at Boston University, and then assistant coach and recruiter at the University of Vermont from 1959 to 1962. From 1962 to 1986, he was the head football coach, head track coach and director of intramurals at Nichols College. His teams won five New England Football Conference titles over a six year span in the 1970's.

He was New England Football Conference Coach of the Year in 1973, 1974, 1975, 1976, and 1978. He was awarded the Honorary Alumnus Award of Nichols College in 1982. Additionally, in 1996, he was inducted into the Nichols College Athletic Hall of Fame for his success as a football coach and athletic director. Finally, in 2005, Nichols College renamed their multipurpose athletic stadium in his honor as the Michael J. Vendetti Field.

He leaves 3 sons, Michael J. Vendetti, Jr. and his wife Kelly of Fairhaven, New Jersey, Mark J. Vendetti and his wife Theresa of Columbus, Ohio, and Paul A. Vendetti and his wife Catherine of Bloomington, Illinois; 7 grandchildren, Paul, Alexandra, Regina, Isabella, twins Michelle and Steven, and Tyler.

is beloved wife of 54 years, Joan F. Vendetti, died in 2011.

The Senator from Norfolk and Suffolk, Mr. Rush, moved that when the Senate adjourns today, it adjourn in memory of Lieutenant Edward Walsh of West Roxbury and Firefighter Michael Kennedy of Hyde Park.

They were among the first at the scene of an explosive nine-alarm fire on Beacon Street in Boston on Wednesday.

Firefighter Kennedy was 33 years old and a U.S. marine who served in Iraq. He was a six-year veteran of the Boston Fire Department.
