Report.

After remarks and pending the question on adoption of the amendment previously recommended by the committee on Ways and Mean substituting a new draft entitled "An Act prohibiting the sale, installation and disposal of mercury thermostats (Senate, No. 1758) and pending the main question on ordering the bill to a third reading, Mr. Rodrigues moved that the bill be amended in section 2 by striking clause (1) of subsection (e) of Section 6J of Chapter 21H in its entirety.

After remarks, the amendment was adopted.

Mr. Pacheco moved that the bill be amended by striking out, in line 161, the figure "2018" and inserting in place thereof the following figure:- "2022".

After remarks, the amendment was adopted.

The pending Ways and Means amendment, as amended, was then adopted.

The bill (Senate, No. 1758, amended) was then ordered to a third reading and read a third time.

Adjourn In Memory of former Tuskegee Airman Luther E. McIlwaine.

The Senator from Essex, Ms. O'Connor Ives, moved that when the Senate adjourns today, it adjourn in memory of former Tuskegee Airman and Congressional Gold Medal Recipient Luther E. McIlwaine.

Luther E. McIlwain, 91, formerly of Methuen, passed away peacefully on Friday, February 8, 2013. Luther was born on September 23, 1921 to the late, Simon and Katherine (Stewart) McIlwain in Blaine, South Carolina.

Luther graduated from Methuen High School in 1939 and attended Allen University in Columbia, South Carolina before enlisting in the Army Air Corps in 1943. He was a Second Lieutenant in the all Black 477th B-25 Bomber Group and was honorably discharged in 1947. As a Tuskegee Airman, Luther was presented with the Congressional Gold Medal by President George Bush on March 29, 2007.

Luther was a New York City Police Officer from 1946-1968 before retiring from the force and returning to Methuen. He then went on to hold several key administrative positions in the city of Methuen including the Office of Equal Opportunity. Luther was commissioned by Governors King, Dukakis and Weld to serve on various boards relating to Affirmative Action and Equal Opportunity Employment.

Luther is survived by his wife, Irene "Mickey" (Graham) McIlwain of Methuen; his loving sister, Glendora McIlwain Putnam of West Roxbury; cousin, Eugene Smith of Andover and close friend, Christopher G. Nihan of Andover.

Luther has touched the lives of many and will be missed by all that had the pleasure of knowing him.
