Met according to adjournment at eleven o'clock A.M. (Mr. Donnelly in the Chair).

Adjourn In Memory of Mrs. Rhonda "Ronny" Zinner

The Senator from Essex, Ms. O' Connor Ives, and the Senator from Suffolk and Middlesex, Mr. Petruccelli moved that when the Senate adjourns today, it do so in memory of Mrs. Rhonda "Ronny" Zinner.

Rhonda "Ronny" Zinner, 70, passed away after a long battle with cancer on Tuesday, March 18, 2014. Born May 15, 1943, in Boston, she was the oldest of the three daughters of Carl and the late Ruth (Gordon) Shapiro.

Mrs. Zinner was a graduate of Boston's Winsor School. She earned a bachelor's degree from Sarah Lawrence College and a master's degree from Boston University's School of Social Work. She was a magna cum laude graduate of the Harvard University School of Education, where she earned a master's degree in education and a certification of advanced study in human development and psychology. In her early career, she was a psychotherapist, focusing her practice on troubled teens and college students. She frequently offered her services for little or no fee to those in need.

Ronny, the wife of Dr. Michael Zinner, chair of the Department of Surgery at Brigham and Women's Hospital shared his dedication where she was a member of the Board of Trustees and, more recently, the President's Advisory Council. As president of the Carl and Ruth Shapiro Family Foundation, she carried out her family's philanthropic vision, overseeing numerous transformative gifts to Brigham and Women's Hospital, including the Carl J. and Ruth Shapiro Cardiovascular Center. Ronny's leadership, empathy and thoughtfulness impacted the lives of countless Boston residents as she built on the philanthropic legacy of her parents. Fueled by a commitment to social justice and compassion for those who struggled, Ronny led the foundation in developing new strategies that empowered people to make positive changes in their lives.

Ronny was also deeply involved in the development of the contemporary art collection at the Shapiro Center, and worked tirelessly in partnership with staff to bring diverse and healing art into the center for patients, families, staff and visitors to enjoy.

Truly, in her work and in her personal life, Ronny's kindness and generosity knew no bounds. She was a true testament of a philanthropist, a friend of people, and her whole hearted commitment to giving back to her community. Her devotion was only surpassed by her husband, Dr. Michael Zimmer, her children; Jennifer Herman and her husband Mark, Jonathan Segal, Dan Zinner, and Darren Zinner and his wife Tracy, her grandchildren; Ashley, Zachary and Alexandra Herman, Coby and Ethan Zinner, her father, Mr. Carl Shapiro and her sisters Ellen Jaffe and her husband Robert, and Linda Waintrup and her husband Daniel Bohrer.
