Thursday, April 3, 2014.

Met according to adjournment at three o'clock P.M.

The President, members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Rosenberg) handed the gavel to Mr. Joyce for the purpose of an introduction. Mr. Joyce then introduced, in the rear of the Chamber, members of the Institute of Real Estate Management Boston Chapter. The group was led by President David Barrett. The Senate welcomed them with applause and they withdrew from the Chamber.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Cynthia Salsman, an employee of the Soldiers' Home in Massachusetts (see Senate, No. 2029), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 10 to 0. The bill was signed by the President and sent to the House for enactment.**

Mr. Rosenberg in the Chair, the yeas and nays having been completed at twenty-three minutes past three o'clock P.M., the bill was passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act making an appropriation for the fiscal year 2014 to provide for supplementing a certain existing appropriation and for certain other activities and projects".

Reports of Committees.

By Mr. Rosenberg, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Bruce E. Tarr, Robert L. Hedlund, Donald F. Humason, Jr., Richard J. Ross and others for legislation to recover assets used in the commission of sexual offenses.

The rules were suspended, on motion of Ms. Chandler, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Consumer Protection and Professional Licensure.

By Mr. Rosenberg, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Stephen M. Brewer and Anne M. By Mr. Brewer, for the committee on Ways and Means, that the Senate Bill authorizing the Division of Capital Asset Management and Maintenance to grant a sewer easement in certain land in the town of Tewksbury (Senate, No. 1485),-- ought to pass, with an amendment substituting a new draft entitled "An Act authorizing the division of capital asset management and maintenance to grant a sewer easement under certain land in the town of Tewksbury" (Senate, No. 2082).

There being no objection, the rules were suspended, on motion of Mr. Finegold, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2082) was then ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.

The Senate Bill authorizing the Wilkinsonville Water District to convey a certain parcel of land (Senate, No. 1995).

There being no objection, the rules were suspended, on motion Mr. Richard T. Moore, and the bill was read a second time.
