Met at three minutes past eleven o'clock A.M. (Mr. Rush in the Chair).

The Chair (Mr. Rush), members, guests and staff then recited the pledge of allegiance to the flag.

Petition.

Mr. Brewer presented a petition (accompanied by bill, Senate, No. 2109) of Stephen M. Brewer, Anne M. Gobi and Todd M. Smola (by vote of the town) for legislation to repeal chapter 511 of the special acts of 1981 [Local approval received]; Under Senate Rule 20, referred to the committee on Municipalities and Regional Government. Sent to the House for concurrence.

Report of a Committee.

By Mr. Welch, for the committee on Health Care Financing, that the Senate Bill relative to synthetic marijuana (Senate, No. 1935),-- ought to pass [Estimated cost -- more than \$100,000]; Under Senate Rule 27, referred to the committee on Ways and Means.

By Mr. Welch, for the committee on Health Care Financing, that the Senate Bill for protection against the transmission of Pertussis (Senate, No. 1093),-- ought to pass with an amendment in line 3, by striking "Section 226" and inserting in place thereof the following "Section 230" [Estimated cost -- less than \$100,000]; Under Senate Rule 26, referred to the committee on Ethics and Rules.
