Monday, May 20, 2013.

Met according to adjournment at eleven o'clock A.M. (Mr. Keenan in the Chair).

The Chair (Mr. Keenan), members, guests and staff then recited the pledge of allegiance to the flag.

Communications.

The following communications were severally received and placed on file:

Communication from Michael G. By the same Senator, for the same committee, on petition, a Bill to authorize the lease of certain property in the town of Ludlow (Senate, No. 1769, changed in line 1 by striking out the words "Section 16 of Chapter 30B of the General Laws or" and by inserting in line 2 after the word "contrary" the words "but subject to paragraphs (a), (b) and (g) of section 16 of Chapter 30B of the General Laws"); [Local approval received];

Severally read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

Committee Discharged.

Mr. DiDomenico, for the committee on Municipalities and Regional Government, reported, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 972) of Karen E. Spilka and Michael Barrett for legislation to assist public water suppliers and to safeguard adequate water supplies,-- **and recommending that the same be referred to the committee on Environment, Natural Resources and Agriculture; Under Senate Rule 36, the report was considered forthwith and accepted. Sent to the House for concurrence.**

Adjourn In Memory of Army Specialist Mitchell Daehling

The Senator from Berkshire, Hampshire, Franklin and Hampden, Mr. Downing, moved that when the Senate adjourns today, it adjourn in memory of Army Specialist Mitchell Daehling.

Army Specialist Mitchell Daehling died while bravely serving his country in Afghanistan last week.

Specialist Daehling, a native of Dalton, graduated from Wahconah Regional High School in 2006. He continued his studies at Daniel Webster College in Nashua, New Hampshire, earning a degree in Homeland Security as a member of the class of 2010. He enlisted in the United States Army in 2010 and was stationed in El Paso, Texas. Specialist Daehling was deployed to Afghanistan as a part of Operation Enduring Freedom in December.

Specialist Daehling was known as a team player, a member of the lacrosse teams for both the Wahconah Warriors and the Daniel Webster Eagles. He is remembered by his family and friends as well-liked, quiet but driven young man.

Specialist Daehling is survived by his wife, Samantha, who he married on June 17, 2012, as well as his parents, Kirk and Brenda Daehling and his siblings, Adam and Kayla.

Accordingly, as a mark of respect in memory of Army Specialist Mitchell Daehling, at four minutes past eleven o'clock P.M., on motion of Mr. Tarr, pursuant to an order previously adopted, and, under the provisions of Senate Rule 38B, the Senate adjourned

to meet again on Wednesday next at ten o'clock A.M. in a full formal session with the only item on the Calendar being the general appropriations bill.
