Monday, June 3, 2013.

Met at one minute past eleven o'clock A.M. (Mr. Petrucci in the Chair).

The Chair (Mr. Petrucci), members, guests and staff then recited the pledge of allegiance to the flag.

Communication.

Communication from the Department of Public Health relative to a plan of correction submitted pursuant to inspections of Plymouth County Correctional Facility, Dartmouth Women's Center, Dartmouth I.C.E. and the Massachusetts Treatment Center (received Friday, May 31, 2013),-- was placed on file.

Report.

Report of the Department of Energy Resources (under the provisions of Section 5 of Chapter 25A of the General Laws) submitting the department's annual employee and program report (received Friday, May 31, 2013),-- was placed on file.
