Thursday, June 13, 2013.

Met according to adjournment at one o'clock P.M. (Mr. Richard T. Moore in the Chair).

Petition.

Ms. Clark (by request), presented a petition (subject to Joint Rule 12) of Kevin Gmelch for legislation relative to out-of-state contractors and sub-contractors,-- **and the same was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.**

Reports of Committees.

By Mr. Barrett, for the committee on Children, Families and Persons with Disabilities, on petition, a Bill to encourage low-income savings and economic opportunity (Senate, No. 19);

By Ms. Donoghue, for the committee on Community Development and Small Business, on petition, a Bill to establish an early education and out-of-school time capital fund (Senate, No. 69);

By the same Senator, for the same committee, on petition, a Bill to lessen the financial burden on small limited liability companies (Senate, No. 70); and

Of the committee on Revenue, asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 3364) of Jason M. Lewis and others for legislation to provide tax incentives to promote housing creation for persons with disabilities,-- **and recommending that the same be referred to the committee on Housing;**

Were severally considered forthwith, under Senate Rule 36, and accepted, in concurrence.

There being no objection, at one minute past one o'clock P.M., the Chair (Mr. Richard T. Moore) declared a recess subject to the call of the Chair; and, at three minutes before two o'clock P.M., the Senate reassembled, the President in the Chair.

The President, members, guests and staff then recited the pledge of allegiance to the flag.

Order Adopted.

On motion of Mr. Richard T. Moore,--

Ordered, That a committee of the Senate be appointed to wait upon His Excellency the Governor, Deval L. Patrick, Constitutional officers and the Honorable Council and inform them that the Senate is in session and awaits their presence for the swearing in of Linda Dorcena Forry as Senator from the First Suffolk District.

Senators Chandler, McGee, Flanagan and Knapik were appointed to the committee.

Subsequently, Ms. Chandler, for the committee reported that His Excellency the Governor, Deval L. Patrick and the Honorable Council would immediately attend upon the Senate.

The committee was discharged.

Soon after His Excellency the Governor Deval L. Patrick, the Secretary of the Commonwealth and the Honorable Council came into the Senate Chamber under the escort of the Sergeant-at-Arms.

After being escorted to the Rostrum, the Honorable Linda Dorcena Forry at ten minutes past two o'clock P.M., on Thursday, June 13, 2013, before the Governor and Council, did take and subscribe the oath of office as State Senator from the First Suffolk Senatorial district.

Senator Forry briefly addressed the Senate as follows:

Thank you Governor Deval Patrick, Senate President Therese Murray,

I want to thank all of you who have come from all over to share in this occasion with me and my family. My colleagues in government from the city, state and county. The campaign volunteers and staff who worked so hard to bring us here today.

Today I begin this role as Senator with my feet firmly planted in a district that has a long, proud history of representation. I particularly want to thank my predecessor, Senator Jack Hart, for his fine service for the last decade in representing the First Suffolk district. Senator Hart, you did us proud and I am grateful to you for your friendship and guidance as we've worked together for our constituents.

Taking on this work— as my colleagues in the House and Senate well know — can be a daunting task. We come to this job with the best intentions and the most noble goals and sometimes we can get distracted with the noise that surrounds this line of work. The politics, the endless campaigns, the fundraising.

But I come to this job with the understanding that we must rise above those distractions. We have work to do. And I arrive here excited to get the job done. I am enthusiastic to work alongside you. I am so proud to have Senate President Murray, a fellow Dorchester native, as our leader. She has been an inspiration to me and I know to you as well.

I'm no stranger to this building. I first arrived here at the State House 17 years ago- fresh out of Boston College- to work as a legislative aide to my good friend Charlotte Golar Richie. I observed first-hand how an effective lawmaker could have a direct and lasting impact on their district and on the whole Commonwealth.

The key is to build partnerships and to maintain them and to honor our word and our commitments to one another. To keep an open door to all of our colleagues. To be someone who seeks common ground and finds a way to tackle the most pressing issues of our day with compassion and a spirit of collaboration.

On this day, as we gather also to bid farewell to our former Gov. Paul Cellucci, I recall that he shared this belief in working together across the aisle. He is fondly remembered in my district for his commitment to the people of Boston and our neighborhoods. Thank you to his family for their shared devotion to our state.

I am so grateful for my colleagues in the House for their work with me over the last eight years. I am particularly grateful to Speaker DeLeo for his faith and confidence in me— for giving me tasks and responsibilities that allowed me to learn and grow and get things done.

I intend to carry that same spirit of collaboration to this distinguished body. Senators, you will find in me a willing partner, an active listener, and I hope, a reliable counselor. Many of you are friends already and those who aren't — we will be. I don't care what party tag you carry, I'm here — like you — to get things done. And in the process we will have a lot of fun too.

I am grateful to all of the people of the First Suffolk district who opened up their homes and their ears to me over the last several months. I've spent my entire life living in the First Suffolk's communities and I have always felt at home in all of its parishes and villages and sidestreets and three-deckers. The people of the First Suffolk share a common set of values: At their core, it's a desire to make our neighborhoods safer, cleaner, healthier and more beautiful. A dream that our kids will have better prospects than we enjoyed growing up. A commitment to each other, a shared bond as Bostonians who care for one another— because that's what we do. We take care of one another, not out of pity or because we have no choice. We seek to be good neighbors because it makes us all stronger as a city, as a Commonwealth.

My focus — as it's been in the House— will be on helping working people find new paths to prosperity. I want to help those who haven't yet found their footing in our recovering economy- to find it and move ahead. The key to strengthening our communities is to help businesses— large and especially small— to do well on Main Streets all over our state. I want to help create jobs in our neighborhoods that are sustainable— open up new paths for homeownership and help those who have struggled with hardships to keep the homes they have. For us to excel as a Commonwealth, all communities must share in the recovery that is under way. That will be a focus that I bring to this chamber.

I come from a Haitian-American home in Uphams Corner. I am so proud today to have my parents — Annie and Andre Dorcena— with me as we begin this next phase of our work on behalf of the people of Boston and this Commonwealth. They are my foundation- I stand on their shoulders and on the shoulders of so many pioneers like them. Men and women who rarely if ever stepped into this chamber, but who've done the hard, quiet, essential work that makes our state thrive and grow. My grandmother, Mammie Anita who just celebrated her 99th birthday.

Mami and Papi, mesi anpil pur tout bagay. etc. in Kreyol, add in a few thoughts about family- kids etc.

And to my partner and husband for 13 years Bill Forry, my children John, Conor, Madeline and Norah. I am here because they make it possible for me to do this work. And I am grateful to them for their faith in me.

The opportunity to serve with you, fellow Senators, in this chamber is one that I treasure. Thank you for welcoming me so warmly. I cannot wait to get started.

Thank you.

Adjourn In Memory of Governor Argeo Paul Cellucci

The Senator from Essex and Middlesex, Mr. Tarr, President Murray and Senators Barrett, Brewer, Brownsberger, Candaras, Chandler, Chang-Diaz, Clark, Creem, DiDomenico, Donnelly, Donoghue, Downing, Eldridge, Finegold, Flanagan, Forry, Hedlund, Jehlen, Joyce, Keenan, Kennedy, Knapik, Lovely, McGee, Montigny, M. Moore, R. Moore, O'Connor Ives, Pacheco, Petruccelli, Rodrigues, Rosenberg, Ross, Rush, Spilka, Timilty, Welch and Wolf, move that when the Senate adjourns today it adjourn in memory of Governor Argeo Paul Cellucci.

Governor Argeo Paul Cellucci of Hudson, died on June 8, 2013 at the age of 65, after a five-year battle with amyotrophic lateral sclerosis (also known as A.L.S., or Lou Gehrig's disease). The son of Argeo and Priscilla Cellucci, Governor Cellucci graduated from Hudson Catholic High School, Boston College, and Boston College Law School. Mr. Cellucci also served as a member of the United States Army Reserves from 1970 to 1978, and earned an honorable discharge attaining the rank of Captain.

Mr. Cellucci began his long and undefeated political career at the age of 21, when he was elected to the Hudson charter reform commission, and then elected to the Hudson Board of Selectmen. In 1976, he was elected as a state representative, and in 1984 was elected as a member of the state senate. From 1991 to 1999 he served as Lieutenant Governor with Governor William Weld. He became Acting Governor in 1997, and was elected Governor in 1998 and sworn in the following January as the Commonwealth's 69th Governor. In April 2001, Governor Cellucci was appointed by President George W. Bush as the 20th United States Ambassador to Canada, where he served till 2005.

Governor Cellucci was able to build a legacy of working in a bipartisan fashion with an overwhelmingly Democratic state legislature in the best interest of the Commonwealth. A few of his accomplishments include the initiative to reduce the state income tax which was approved by the voters in a 2000 referendum, and maintaining high educational standards for the state's public schools. He also appointed many women to high ranking positions, including the honorable Margaret H. Marshall as the first female Chief Justice of the Massachusetts Supreme Judicial Court, Marshall's appointment marked the first time a woman headed a branch of government in Massachusetts history. Additionally, his selection of Jane Swift as his running mate for lieutenant governor in 1998 led to her becoming the only woman to lead the Commonwealth as Acting Governor, when he was appointed as Ambassador to Canada.

In January 2011, Mr. Cellucci made public that he was battling A.L.S. He devoted the rest of his life to raising money for the Champion Fund, which he helped to create at the UMass Medical School to fund ALS research. Mr. Cellucci was a devoted family man, he and his high school sweetheart Janet Garnett were married for 41 years, and he was also able to see his fourth grandchild born on May 17th.

Governor Cellucci is survived by his wife Janet, his daughters Kate, and Anne; four grandchildren; his sister Roseann; and his brother Peter.

Accordingly, as a mark of respect in memory of Governor Argeo Paul Cellucci, at sixteen minutes before three o'clock P.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
