### JOURNAL OF THE SENATE.

*Friday, June 27, 2014.*

Met at two minutes past eleven o'clock A.M. (Mr. Petrucci in the Chair).

The Chair (Mr. Petrucci), members, guests and staff then recited the pledge of allegiance to the flag.

#### *Reports of a Committee.*

By Mr. McGee, for the committee on Transportation, on petition, a Bill to designate a certain bridge in the town of Needham as the Reverend (LT) Daniel J. Kennedy, USN Memorial Bridge (Senate, No. 2170); and

By the same Senator, for the same committee, on petition, a Bill to designate a certain bridge over the Merrimack River as the Congressman William H. Bates Veterans Memorial Bridge (Senate, No. 2171);

**Severally read and, under Senate Rule 26, referred to the committee on Ethics and Rules.**

#### *Committees Discharged.*

Mr. Rosenberg, for the committees on Rules of the two branches, acting concurrently, reported, asking to be discharged from further consideration

Of the Senate Order relative to authorizing the joint committee on Environment, Natural Resources and Agriculture to make an investigation and study relative to the Global Warming Solutions Act (Senate, No. 2225);

Of the Senate Order relative to authorizing the joint committee on Financial Services to make an investigation and study relative to public funds (Senate, No. 2226); and

Of the Senate Order relative to authorizing the joint committee on Telecommunications, Utilities and Energy to make an investigation and study relative to greater responsiveness of telephone rates to consumer demand (Senate, No. 2228);

**And recommending that the same severally be referred to the committee on Ethics and Rules.**

**Under Senate Rule 36, the reports were severally considered forthwith and accepted**

### PAPERS FROM THE HOUSE

#### *Bills*

Authorizing the conveyance of certain land in the city of Holyoke (House, No. 4113,-- on House, No. 4033); and

Authorizing the commissioner of capital asset management and maintenance to convey certain parcels of land in the town of Medfield (House, No. 4216, amended, -- on House, No. 4107);

**Were severally read and, under Senate Rule 27, referred to the committee on Ways and Means.**

#### *Reports of a Committee.*

By Mr. Brewer, for the committee on Ways and Means, that the Senate Bill relative to the Massachusetts Broadband Institute (Senate, No. 2184),-- **ought to pass.**

**There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered**

**to a third reading, read a third time and passed to be engrossed.  
Sent to the House for concurrence.**

The House Bill relative to the preparation of certain bilingual ballots in the city of Boston (House, No. 4089),-- ought to pass, with an amendment in section 4, by inserting after the first sentence the following sentence:- "The board's determination shall be made in recognition of its duty under this act to provide the necessary voter assistance to the city's Chinese and Vietnamese speaking communities."

**There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was amended, as recommended by the committee on Ways and Means.**

**The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment.**

**Sent to the House for concurrence in the amendment.**

By Mr. Brewer, for the committee on Ways and Means, that the House Bill promoting economic growth in the Commonwealth (House, No. 4181),-- **ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2231.**

*Order Adopted.*

Mr. Brewer offered the following order, to wit:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the House Bill promoting economic growth across the Commonwealth (House, No. 4181) (the committee on Ways and Means having recommended that bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2231) shall be placed in the Orders of the Day for a second reading on Tuesday, July 1, 2014.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 10:00 A.M., on Sunday, June 29, 2014. All such amendments shall be second-reading amendments to the recommended Senate Ways and Means new text (Senate, No. 2231) but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

**Under the rules, referred to the committee on Ethics and Rules.**

**Subsequently, Mr. Rosenberg, for the said committee, reported, recommending that the order ought to be adopted.**

**The rules were suspended, on motion of Mr. Tarr, and the order was considered forthwith and adopted.**

**The bill (House, No. 4181) was then placed in the Orders of the Day for a second reading on Tuesday, July 1, with Ways and Means new text (Senate, No. 2231) pending.**

*Order Adopted.*

On motion of Mr. Tarr,--
