JOURNAL OF THE SENATE..

Thursday, September 18, 2014.

Met at five minutes past eleven o'clock A.M. (Ms. Spilka in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Spilka), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Ms. Spilka) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, a group of sophomores and juniors from St. Kevin's College in Melbourne, Australia. The students were on a school trip to Boston and learning about the different aspects of state government. The Senate welcomed them with applause and they withdrew from the Chamber. They were accompanied by Mary Hardwick. They were also guests of Representative Hill.

Communications.

The following communications were severally received and placed on file:

Sent to the House for concurrence.

The House Bill relative to certain municipal salaries in the city of Lynn (House, No. 4335),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

Reports of Committees.

Mr. Rosenberg, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill validating the results of a certain election held in the town of Lancaster (printed in House, No. 4331). There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

PAPERS FROM THE HOUSE.

The Senate Bill establishing the MetroWest commission on the status of women and girls (Senate, No. 1920),-- came from the House passed to be engrossed, in concurrence with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4356; and by striking out the title and inserting in place thereof the following title: "An Act establishing the MetroWest commission on the status of women."

The rules were suspended, on motion of Mr. Tarr and the House amendment was considered forthwith and adopted, in concurrence.

Engrossed Bills.

The following engrossed bills (all of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Ms. Spilka) and laid before the Governor for his approbation, to wit:

Authorizing the town of Dartmouth to establish an enterprise fund (see House, No. 3623);

Granting an additional license for the sale of alcoholic beverages in the town of Milton (see House, No. 4191, amended); Establishing a sick leave bank for Kathleen Restuccia, an employee of the Trial Court (see House, No. 4381, amended); and Establishing a sick leave bank for Michael J. Macuch, an employee of the Department of Correction (see House, No. 4407, amended).

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Tracy Longvall-Rivera, an employee of the Department of Youth Services (see House, No. 3904), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Ms. Spilka) and sent to the House for enactment.

Engrossed Bills.

Adjourn In Memory of Army Specialist Brian K. Arsenault

The Senator from Worcester, Ms. Chandler, moved that when the Senate adjourns today, it do so in memory of Army Specialist Brian K. Arsenault of Northborough.

Brian K. Arsenault, of Northborough, was valiantly killed in action on Thursday, September 4, 2014 at the age of 28 while serving with Company B, 1st Battalion 504th Parachute Infantry Regiment, 1st Brigade Combat Team, 82nd Airborne Division in Ghazni, Afghanistan.

An excellent athlete, Specialist Arsenault played varsity hockey for four years while attending Algonquin Regional High School.

He completed U.S. Army Basic Training and Infantry School at Fort Benning, Georgia in 2011, and graduated from Airborne School at Fort Benning and was then assigned to his current unit in 2012.

The Bronze Star, Purple Heart, Army Commendation Medal, Combat Infantry Badge, National Service Medal, Afghanistan Service Medal and numerous others have been awarded to Specialist Arsenault.

He is survived by his loving parents, Daniel W. and Leslie (Sebastian) Arsenault and beloved sister, Lindsey Beth Arsenault, all of Northborough. He also leaves many aunts, uncles, cousins and extended family which include a large group of close friends, many since preschool.
