JOURNAL OF THE SENATE.

Monday, September 30, 2013.

Met at two minutes past eleven o'clock A.M. (Mr. Donnelly in the Chair).

The Chair (Mr. Donnelly), members, guests and staff then recited the pledge of allegiance to the flag.

Communication.

A communication from the Honorable Bruce E. Tarr, Minority Leader, announcing certain changes to Joint Standing Committees and Senate Standing Committees, to wit:

Petition.

The House Bill providing for recall elections in the town of Middlefield (House, No. 3411, amended),-- **was read a second time, ordered to a third reading, read a time and passed to be engrossed, in concurrence.**

Holmes and Linda Dorcena Forry for legislation to authorize the Division of Capital Asset Management and Maintenance to convey certain parcel of state owned land to the city of Boston,-- **was referred, in concurrence, under suspension of Joint Rule 12, to the committee on State Administration and Regulatory Oversight.**
