Thursday, October 16, 2014.

Met at three minutes past at eleven o'clock A.M. (Ms. Chang-Díaz in the Chair).

The Chair (Ms. Chang-Díaz), members, guests and staff then recited the pledge of allegiance to the flag.

#### Communications.

The following communication were severally received and placed on file, to wit:

Communication from the Honorable Benjamin B. Downing in compliance with Massachusetts General Laws Chapter 268A (received in the Office of the Clerk of the Senate on Wednesday, October 15, 2011, at twenty-three minutes past ten o'clock A.M.); and

Communication from the Executive Office of Administration and Finance (under the provisions of Section 3B of Chapter 7 of the General Laws) submitting notice of a proposed fee change by the Department of Fish and Game for permitting fees for lobster permits (received October 14, 2014).

# Committee Discharged.

Mr. Lewis, for the committee on Public Service, reported, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 2363) of Mark C. Montigny and Christopher M. Markey (by vote of the town) for legislation to authorize the appointment of special police officers in the town of Dartmouth,-- and recommending that the same be referred to the committee on Municipalities and Regional Government;

Under Senate Rule 36, the report was considered forthwith and accepted. Sent to the House for concurrence.

# PAPERS FROM THE HOUSE.

A Bill providing the terms of certain bonds financing the expansion of the Boston Convention and Exhibition Center (printed in House No. 4444,-- being a message from His Excellency the Governor),-- was read and, under Senate Rule 26C, referred to the committee on Bonding, Capital Expenditures and State Assets.

A Bill authorizing the town of Mansfield to grant additional liquor licenses (House, No. 4413, amended-- on House, No. 4361) [Local approval received on House, No. 4361],-- was read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

# Resolutions.

The following resolutions (having been filed with the Clerk) were severally considered forthwith and adopted, as follows:-

Matters Taken Out of the Orders of the Day.

Pending the question on ordering the bill to a third reading, Mr. Tarr moved that the bill be amended by striking out, in lines 11 and 12, the words "and upon retirement, he or she shall receive a superannuation retirement allowance equal to that which he would have been entitled had he retired at 65".

The amendment was adopted.

The bill (Senate, No. 2178, amended) was then ordering to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act allowing certain senior support staff members of Protection Fire Co. No. 1 Byfield, Massachusetts to continue to serve beyond the age of 65."

Sent to the House for concurrence.

The bill (Senate, No. 2385) was then ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.
